Private development contract 9345 is for the public improvements required for the Dane County Jail Consolidation located at 118 W Wilson Street. The public improvements and right-of-way work are proposed for the project frontage on W Wilson Street. Public surface improvements will include sidewalk, street terrace, curb & gutter, and pavement restoration. Public utility improvements will include a new sanitary sewer access structure to allow for connection of private sanitary service lateral and incidental adjustments to an existing storm sewer inlet for the private storm service lateral connection. Existing public street trees adjacent to the project will be protected and one new public street tree will be installed per City Forestry approvals on W Wilson Street. Private work within the public right-of-way will consiste of the private service laterals and the private driveway arpons necessary to facilitate the project. The construction of this project will need to be coordinated with the City's pending W Wilson Street reconstruction project.

The project is located on the East side of Madison, and will consist of installing a booster pump and associated piping in the existing control building at our reservoir on Felland Road. This will allow us to pump water into multiple zones on the East side, increasing resiliency, and alleviating existing pinch points. The total estimated cost of the project is \$300,000.
