Western Addition to 1000 Oaks Phase 4 was previously approved by the Board of Public Works at the February 22, 2023 meeting with a condition of approval to provide an interim bike path connection from Old Timber Pass to Sugar Maple Lane. Design of the interim bike path connection has revealed that significant storm sewer (twin box culverts) will be needed to address drainage through this area. These storm sewer improvements would need to be completed on lands currently not under the Developer's or City's control. A future public works project is planned to complete the missing segment of Sugar Maple Lane once the required right-of-way is acquired and dedicated to the City (this project is anticipated for 2024 or 2025). Re-approval of this project is being requested without the interim bike path connection requirement in order to avoid significant delays to the proposed development and to allow the City to budget for its portion of the future improvements.

Contracts 9340 & 9341 are for the construction of public improvements required for the construction of Acacia Ridge Phase 10 by the developer, East South Point, LLC (a.k.a. Veridian Homes). This phase is located in the southeast corner of the plat that contains Replat No. 2 and their conditionally approved Replat No. 4. Public street improvements will include City standard sidewalk, curb & gutter, terraces, and street pavement. Street improvements on Valley View Road will include ingress/egress improvement for the plat, sidewalk, curb & gutter, pavement, and medians. The geometrics for Valley View Road were presented at Traffic Commission on 8/9/23 for comment and were found to be acceptable for this application. Public utility improvements will include City standard sanitary, storm, and water mains. Private sanitary and water service laterals will also be installed to serve the lots within the construction phase. Contract 9340 will contain all improvements except for the final asphalt surface paving which will be covered in contract 9341.
