The City is planning the construction of a bike path on the Northeast Park (Tancho Drive to the Underpass 151) to help connect the City of Madison to the City of Sun Prairie. The project is going to consist of a 10' wide shared-use path that will go through the Northeast Park but leave space for a future development of the open space to the north (currently is farmland) and the wooded area to the south (future single-track). Path lighting will be included along the entire project, improvements will be made at the Tancho Drive crossing, a redesign of a portion of the Northeast Open Space Tancho Path to connect with the new path, and minimal tree removals on wooded areas. Stormwater impacts anticipated to be minimal, as the path will follow existing contours and maintain existing drainage patterns. Estimated project cost is \$680,000.

Within the project limits, the existing storm sewer that runs parallel to the Capital City Trail is primarily a 3.5'x2' box culvert, installed in 1909, and is in poor condition. This proposed project will replace the storm sewer from just east of Blount St. to east of

Brearly St. with a 4'x6' storm sewer. The proposed increased storm sewer size has been designed in coordination with regional flood mitigation planning. The project area includes existing established prairie plantings and the City will coordinate with volunteers to salvage and restore the garden.
