RESOLUTIONS APPROVING THE CONSTRUCTION OF PUBLIC WORKS PROJECTS

36. 05413

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for the Park Street Reconstruction (southbound lanes only) and Construction of Relief Storm Sewer. (13th AD)

Reconstruct the southbound lanes of S. Park Street between Haywood Drive and Erin Street and construct a Relief Storm Sewer System in the alley between the 700 and 800 blocks of S. Park Street extending from S. Park Street to Lake Monona to improve drainage and reduce the potential for flooding of the street and adjacent buildings during rain storms up to a 100 year event. The current storm sewer system can handle less than a 1 year event. Estimated cost is \$945,000.

37. 05543

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Restoration/Landscaping 2007, Contract No. 6038. (City Wide)

Total estimated cost of this project is \$50,000.00. Project is proposed in order to repair, maintain or restore stormwater and other facilities throughout the City as needed in public greenways, detention basins, street right of ways and other City owned properties.

38. 05545

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Westmorland Park Greenway, Contract No. 6040. (11th AD)

The Westmorland Park Greenway project proposes to enclose an existing wooded drainage ditch in the Westmorland Park with a large eliptical concrete pipe in order to convey storm water flows and stop the existing erosion problem. This design has already been permitted by the WDNR and approved by the Parks Commission. Consideration has been taken to save as many of the existing trees as possible and provide for storm water treatment via a bioretention system. Estimated cost is \$130,500.

39. 05546

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for University/Highland Intersection Relief Storm Sewer, Contract No. 5991. (5th AD)

This project, and associated reconstruction in 2009/2010 will significantly reduce the flooding currently experienced at this intersection. It is expected that upon completion of all projects the area will be protected to approximately the 10-year storm event. Estimated cost is \$100,000.

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Fairchild Building Concrete Restoration, Contract No. 6037. (4th AD)

Estimated cost of this project is \$149,100. Concrete floor repair and restoration on ground floor and first floor. Removal and replacement of unsound structural floor pan and concrete followed by sealing topside cracks and joints.

41. 05551

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Sign Shop HVAC Modifications, Contract No. 6039. (4th AD)

Estimated cost of this project is \$104,000. This project will consist of replacing existing the HVAC unit, light fixtures, and ceiling tile in the sign shop for improved air flow ventilation. Add new roof mounted condensing unit, supply- air ducts, return-air ducts, and linear ceiling diffusers. Replacement of light fixtures shall be T8 high efficiency ballasts with dual switching for improvement energy savings.

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Senior Center Dining Wood Floor Replacement, Contract No. 6042. (4th AD)

Estimated cost of this project is \$45,700. This work consists of replacing the wood flooring in the dining area located on first floor; removal of worn and damaged wood parquet; and the installation of new maple engineered hardwood strip flooring. Project area is approximately 2,100 square feet.

Approving plans and specifications for the Installation of Arterial Pedestrian Enhancements on Capital Avenue between University Avenue and Old Middleton Road. (19th AD)

Arterial Pedestrian Enhancements on Capital Avenue are part of the Local Road Traffic Calming & Arterial Pedestrian Enhancements - 2007 Contract. Estimated cost of this project is \$11,100.

44. 05569

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Mineral Point Road and Gammon Road Pavement Repairs - 2007, Contract No. 6013. (9th & 19th ADs)

This is first year in a two-year project to complete concrete pavement repair on Mineral Point Road from Grand Canyon Drive to the West Beltline Highway and Gammon Road from the West Beltline Highway to Tree Lane. The project will entail the replacement of deteriorated concrete pavement on Mineral Point Road and Gammon Road. The project will be completed in an expedited fashion to minimize the impact on traffic. In order to expedite the project, it is recommended that certain construction activities will need to take place between the hours of 7:00 PM and 7:00 AM. A public hearing on the night construction will be completed prior to bidding in accordance with the Madison General Ordinances. Cost estimate will be available at the Board meeting.

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Concrete Pavement Rehab - 2007, Contract No. 5808. (Various ADs)

The project consists of repairing concrete pavement in various locations throughout the City of Madison as needed during the 2007 construction season. The project consists of removing deteriorated joints in concrete pavements by saw cutting out concrete sections typically four feet wide by the width of the concrete section and replacing it with new concrete pavement that is tied to the existing pavement with steel dowels and tie bars. The repairs will be done to minimize the impact on traffic. Cost estimate will be available at the Board meeting.
