		This is the annual tennis court resurfacing contract for the Parks Division. This year's contract will include the crack repair and resurfacing of tennis courts in Tenney Park (\$16,000) and Warner Park (\$24,000) Total estimated cost is 40,000. Report by Tom Maglio, Parks Division.

Presently the site is constantly eroding to the point where it is necessary to install pea gravel on an annual basis to assure it is a safe access point. Total estimated cost is \$50,000. Neighborhood by installation of cured-in-place pipes. Estimated cost of this project is \$275,000.00.
