This project is for the construction of a splash pad at Elver Park and a splash pad at Reindahl Park. Estimated cost of this project is \$950,000.00.

West Badger Road water limits are from Fish Hatchery Road to the west dead end. Construction will replace approximately 1,300 feet of existing 6-inch water main with new 8-inch main. This work will upsize and upgrade this break-prone existing water main. Estimated cost of this work is \$275,000.00.

Lancaster Drive water limits are from High Crossing Boulevard to Wayne Terrace. Construction will add approximately 1,000 feet of new 16-inch water main. This work is the first leg of Hwy 151 crossing to improve Pressure Zone 3 supply redundancy. Estimated cost of this work is \$210,000.00.
