Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Lower Badger Mill Creek Sanitary Sewer Interceptor Phase 2 & 3. (9th AD)

Phase 2 of the Lower Badger Mill Creek will include the installation of 8,379 of sanitary sewer from Valley View Drive northwest through City acquired easements (cropland) as well as 1050' of Pioneer Road up to Mineral Point Road. Phase 3 will include 5,055 feet of sanitary sewer interceptor extending northeast from Valley View Road through City acquired easements through lands primarily used for cropland, through platted right of ways of the Thousand Oaks development until reaching the South Point Lift Station in the Silicon Prairie development (See Attached Map). Phase 2 will provide sanitary sewer service to the west half of the Birchwood plat which is located just west of the Silicon Prairie Development as well as lands north of Mineral Point Road where sewer has become in demand. Phase 3 will allow the City the ability to relieve the South Point Lift Station which is close to reaching design capacity. After completion, the interceptors Phase 1(already built), phase 2 and 3 will make sanitary sewer available to a 2,667 acre Lower Badger Mill Creek Watershed. All Sewer improvements will be paid for by the Lower Badger Mill Creek Sanitary Sewer and Stormwater Management Impact Fee. Estimated cost of Phase 2 is \$1,750,000 and Phase 3 is \$950,000.
