#### 9. ACCEPTANCE OF LSTA GRANT

Last year, library staff applied for a Library Services & Technology Act grant ( administered through the Wisconsin Department of Public Instruction) for a Bubbling Up! Digital Creation for Teens at Madison Public Library. This grant will allow Madison Public Library to showcase its Bubbler program and Digital Media Lab space to Madison and Dane County area teenagers through partnering with organizations who serve low-income teens. A teen internship program will pair teens with an adult mentor to work on self-guided digital learning projects of interest to them and to gain relevant teaching and work experience and professional connections for seeking employment or higher education in the field of digital media production. The library will provide a series of workshops throughout the year that will give all area teens the chance to learn how to create their own video games, create book trailer videos, and tell their stories through digital formats.
