113 Elm Street (M-02-01-2014) The Builders Group, Inc. appealing SPS 321.03(3)(B), each habital floor above the second floor shall be provided with two exits when the area consists of more than one room and the room is used for sleeping. There are three rooms. The space in question is being completely remodeled and they do not want to sprinkle the space. In addition, appealing SPS 321.04, stairway headroom required 6' 4". They currently have 5' 0". Required stair width is 36" and they currently have 32". Required treads are 9" and there is currently 8 3/4". Required handrail is 30" - 38" and it is currently 25".

In addition, appealing SPS 321.06, which requires ceiling height of 7' 0" and they currently have 6' 10". In addition, SPS 321.03(3)(B), smoke detection shall be continuously powered

by the house electrical service and interconnected so that activation of one detector will call activation of all detectors.
