4.	<u>55962</u>	Adopting and confirming the modification to the Agreement between the City of Madison and the Association of Madison Police Supervisors (AMPS) for the period January 1, 2018 through December 31, 2021.
5.	<u>56021</u>	Judge Doyle Block 88 Proposals - Presentation of Report and Consideration of Possible Resolution to Select a Developer
6.	<u>56020</u>	Approving the Selection of a Judge Doyle- Block 88 Development Team with Whom to Commence Negotiations and Directing Further Actions.
