In 2018, the City created a new policy guiding conversions of planting beds around the Capitol Square to new sidewalk café space (file #50596, RES-18-00291). Prior to creating this policy, 3 planter beds around the Capitol Square had been used as café space, and this project would modify those cafes to be more consistent with the policy for new planter bed conversions. The 3 locations are Genna's (105 W. Main St.), Boar & Barrel (101 N. Hamilton St.), and Tipsy Cow (102 King St.). This project would preserve existing landscaping and tree plantings (Boar & Barrel and Tipsy Cow) or create new tree planting location(s) (Genna's) and modify the café space to be ADA accessible. Estimated cost is \$60,000.
