59818 Community Engagement March 2020

No report. Next Meeting on 3/19. Darriel Harris (Johns Hopkins CLF) is drafting a

recommendations report for the MFPC on community engagement approaches that infuse racial equity considerations.

#### 59819 Food Waste and Recovery March 2020

The Food Waste Reduction Task Force met on February 19. Because of the holidays in November and December and a scheduling mix up in January, we had not met since October, 2019. With changing committee membership at the Dane County Food Council our first order of business was to assess our membership roster. From the City of Madison Food Policy Council Chris and George remain members, while membership from the Dane County Food Council is Christine Ameigh, Michelle Ritt, and Jess Guffey-Calkins. Citizen members include Lindsay Karls from Community Action Coalition and Logan who works in culinary at Promega and operates their expanding garden/farm production. For the rest of the meeting we took up the proposed strategic plan for the task force from the Dane County Food Council's planning session in 2019. Our strategies for 2020 include: supporting, advising, and having a presence at partner events including reaching out to WasteCap in Milwaukee about future Food Waste Reduction Convocations, continue to promote the Food Waste and Recovery Guide, institutionalize a process for review and update of the Food Waste Recovery Guide, renew our efforts to install a No Thank You Table policy at Madison metropolitan School District and collaborate with Extension's Healthy Communities Program, develop outreach materials to educate citizens on food waste reduction, explore composting programs, and support the City's food waste biodigester study.
