This project was at the 5/19/21 BPW meeting and approved per resolution RES-21-00392. The Developer, FCS Plan B LLC, has obtained conditional approval from the City of Madison to create a one-lot CSM and redevelop the property into a mixed-use development. The project will include 63 apartments, 23 surface parking stalls, and 37 underground parking stalls. The proposed new building will front Bowen Ct while the entrance to the underground parking will be off of N Randall Ave. Since the previous approval, the Developer has submitted the sanitary flow calculations for the project as required by one of the conditions of approval. Review of the sanitary data indicated that a section of existing sanitary sewer crossing Regent Street at Orchard Street will need to

be upsized in order to provide sufficient sewer capacity to serve the project. The City Sanitary Sewer Utility will reimburse the Developer \$2,500.00 for the sewer improvements which is equivalent to the cost for the City Sanitary Utility to maintenance line the upgraded sanitary sewer.
