And you're absolutely right re: other students living along Ridgeway Avenue being more likely to use Lexington - it acts as the primary connector/collector street from that neighborhood, which is on a hill and a little isolated, to Hawthorne. Reality is of course there's a critical mass of students coming from the apartment complex where the route begins.

It definitely could be that families are choosing that intersection over Melvin because it looks safer because of the median. It's also closer to the school by two blocks so that could be another reason why it seemed/is more popular based on our observations.

Grant's referring to a Hawthorne Elementary walking school bus route from we launched last fall. See attached for route #1 information.

He audited the route with me before we officially started the route. Crossing East Washing was difficult - we observed students and heard from parents & others at the school that crossing this 35 mph stretch with no controlled intersections between the highway clover and N. Fair Oaks is a barrier to students/walkers living in Ridgeview Heights.


The Rethke/Melvin idea is along the route and could be interesting, but we'd identified East Washington & Lexington as potentially a better one to study and potentially improve. This intersection was specifically identified by parents & school stakeholders as unsafe without prompting. It has a painted cross walk but no beacon and little signage if I recall correctly. This is the current favored location to cross East Wash (over Rethke) in our observations of students on the route.

Good evening Alder Rummel and Lori,

Thank you for reaching out! We have taken a note on the signal request for Second St and E Washington Ave, and will evaluate the request using the City's Traffic Signal Priority List process adopted by the Common Council. The below document lists the criteria for installing traffic signal, and staff will collect data, perform warrant studies, prepare a rank order priority list and present that to the Transportation Commission. The Commission will make the final decision on which intersections to signalize.

We just went through the process for all the 2020 requests, and this one will be considered with other 2021 requests. We should be able to know the final results by early 2021, and we will keep you informed before we bring this item to the Transportation Commission late this year and early next year.

You are correct that First St and E Washington Ave is one of the most challenging intersections in the city as it handles large volume of traffic. We will continue to look for ways to improve the intersection especially for pedestrians and other vulnerable users, and will carefully watch the potential impacts brought by the continued development in the area.

We agree with you on the importance of robust pedestrian safety considerations in the BRT planning process, and will work with the BRT team on that, especially for those locations near BRT stations where we expect increased number of pedestrians.

Last week Alder Abbas had a neighborhood meeting about the new mixed use development proposal at 1st and East wash and the 1st Street intersection was discussed at length. Mark Winter from traffic engineering was there and he heard all the concerns from neighbors about crossing that intersection, E Mifflin and adding a public crossing at the railroad tracks and Burr Jones Park. Safety in this area is something the city is very aware of.

As you probably know, we started the pilot called Vision Zero that among other initiatives reduced the speed limits along this stretch of East Washington Avenue..If you search for it on the city website, you should be able to get more information.

I am copying the City Traffic Engineer Yang Tao, Asst City Traffic Engineer Mark Winter, Transportation Director Tom Lynch, Alder Syed Abbas and Alder elect Brian Benford.

I wrote to you several months ago with the following concern about pedestrian and bicycle safety at the E. Washington and First St intersection. I realize that your term is ending soon, so I wonder if it would be more appropriate if I send my request to the City Transportation Board? I would appreciate any advice that you have. I am including my original email below. Thank you for your help.

Lori Guderyon

I am writing with a concern about pedestrian and bicycle safety at the intersection of East Washington Ave and First Street. With the upcoming Public Market opening on First Street, I anticipate that there will be increased car and pedestrian traffic at that intersection.

Having lived in the neighborhood for 40 years, I can testify that the intersection is NOT a safe one for walkers and bikers. The left turn arrows on First Street (in both directions) are given too little time, so cars end up racing through their left turns, thus jeopardizing pedestrians' lives in the crosswalk. On the Next Door social media site, several people have described "near death" experiences trying to use that crosswalk. And there has been at least one bicycle fatality at that corner, to my knowledge. I assume that City Traffic Engineering is aware of the future increase, and is planning to make changes to prevent future fatalities of pedestrians or bicyclists. If so, do you know the traffic planning process, and if public input will be part of the process?

With the many new apartment buildings and condos being built in the Atwood Ave area, I'm predicting that there will be more foot traffic crossing East Washington to the new market. And even though there is the Yahara River bike path under the street, I don't think many walkers will go several blocks out of their way to use it. Do you know if the Traffic dept has considered the option of putting a traffic light at E Washington and Second St, or an alternative for pedestrians to safely cross to the planned Public market?

I'm wondering if you could let me know the best way to give input to the city about this issue. I am also willing to work with others to create a petition for a safer crosswalk, if that would be helpful to make our voices stronger. I live at Linden Cohousing, and I'd be willing to recruit a group of people here to collect signatures, or whatever is needed. Since we are 45 households who live close to that intersection, we definitely want to be sure that pedestrians are granted equal rights to safety!

Thank you much for any advice or information that you can give.

Good afternoon Alder Evers,

Thank you for reaching out! Great question.

We did look into a potential traffic signal at Edgewood-Monroe during the Monroe St reconstruction project a few years ago and also most recently through our last year's Traffic Signal Priority List, which is the City's mechanism to decide which intersections to signalize.

The decisions through both processes were not to signal the intersection. The intersection came short to meet the traffic signal warrants set by the national standards by 41 percent. There are also considerations such as coordination with nearby signals and geometric changes to manage the offset intersection. We also heard significant opposition from the nearby residents to the signal, as a signal typically attracts more traffic to that street.

Because of all these, we don't expect the intersection be signaled in the near future. We will continue to monitor the intersection for growing traffic and signal needs.

I am hoping you can assist. I think Edgewood School needs to send a reminder to parents that they are driving (racing) through a residential neighborhood to take their children to school. I left my home on Madison Street between Edgewood and Lincoln at 7:40 this morning and watching the cars racing up Jefferson and Adams was frightening. Children from our neighborhood were walking to their schools and bus stops and those in cars seemed to be paying no attention to stop signs and no consideration to the children around them.

In addition, I don't understand why there isn't a light at Edgewood and Monroe. The chicane is dangerous, and again, lots of traffic now that school has started. When I looked across Monroe, there were at least 10 cars trying to either get across or turn. After all the work that was done on Monroe street, I don't understand why a light wasn't put in. Very few pedestrians actually use the available flashing lights and many days, we have to turn right, go a block or two down Monroe to make a left and circle back down West Lawn to make a right on Monroe because making a left off Edgewood or Lincoln is impossible.
