Applicant's Comments: We are requesting demolition permit approval for the one story structure located at this site. The proposed development is a five-story mixed use building with 59 dwelling units and underground parking. Staff Findings: A preservation file for this property does not exist. The Wisconsin Historical Society property record indicates that the Art Moderne tavern, historically known as Justo's Bronx Club Tavern, was started by Mrs. Jennie Justo Bramhall and later became Smoky's Club.

**Applicant's Comments**: Requesting permit approval for the demolition of the existing Church building that is currently on the site, as that is no longer being used. The site redevelopment will consist of a 3 story multi-family development with underground parking.

**Staff Findings**: A preservation file for this property does not exist. A Wisconsin Historical Society property record exists but does not contain additional information. A search in the Building Inspection files finds that this structure was designed by Krueger, Shutter & Associates. After local architecture and engineering firm Krueger, Kraft, and Associates

dissolved in 1965, Lloyd O. Krueger formed Krueger, Shutter & Associates and continued designing Midcentury Modern structures. Lloyd Krueger's most famous design is Holy Name Seminary in Madison.
