# Customer Services (Front Desk) – Joanne Austin (Liz Levy, Interim Lead)

## Permits (Disc Golf, Dog Park, Lake Access, Cross Country Ski)

Annual permit sales of all types continue to increase and this held true in 2021. 2022 Permits have been available for purchase since early November. There was a notable increase in annual sales and decrease in daily sales starting in 2020. This is likely attributed to factors arising from COVID-19, including closing the on-site kiosks and increased interest in outdoor activity in the parks. Patrons have become increasingly comfortable with purchasing their permits online, rather than leaving payments in our iron canisters in the parks. This has helped to streamline the process and customers are receiving their permits in a more timely manner than they did in years past.

## Boards, Commissions and Committee (BCC) Meetings

# Watercraft Storage (Canoe/Kayak)

The watercraft storage program continues to be popular and additional storage racks needed to be placed at various lakeside parks over the years. Each annual lease agreement is valid through March 31 and we'll soon be reaching out to current users to see if they wish to renew or open their space to others on the waitlist. There are currently 261 requests to be on our waitlist.

## **Community Events in 2022**

While we are all still navigating the COVID-19 pandemic, we are certain the requests for events in our City of Madison outdoor spaces will continue to increase as they did in 2021. The Community Events Team will continue to be flexible and efficient with responses to new, old, and varied event requests.

The online Park Event Permit application is still on track to be ready in early 2022 for Park Event organizers. This online application option will make the Park Event permitting process easier and more accessible for applicants.

The Community Event team is also updating applications, permits, and event websites for the New Year.

## **Recreation Services (Tracey Hartley):**

- Riley Berning, Winter Attendant Coordinator has been working very hard to prepare the locations to be ready for opening day! Anticipate opening Elver the weekend of Dec. 31, just in time for the New Year. Winter Recreation Rental locations open this winter season include: Elver, Tenney, and Vilas with limited hours and days open. Staffing the locations has been a challenge to find enough staff coverage and still working on finding coverage. Loaner skates will be available at Rennebohm, Westmorland, Warner, and Olbrich once open for the season. Information about winter fun can be located at cityofmadison.com/parks/winterfun. Hope you can get out this season to enjoy all that winter has to offer.
- Winter event plans are underway and we will be back to offerings the Groove & Glide events at five winter locations. Two Candlelit snowshoe hikes scheduled. Learn to Play Hockey & Curl are in the planning phase, and the Skate Cinema, movie, at Tenney will be on Sat. February 12 Space Jam: A New Legacy. - Posting is out as of 12/28/2021 for the new Aquatics & Parks Program Coordinator position at Parks. Plan is to have person hired late February/early March 2022.

# Aquatics/Goodman Pool – (Jon Landsverk):

The 2021 Aquatic season ended for the pool on August 29<sup>th</sup> and for the beaches and splash pads on September 6<sup>th</sup>.

- 143 scholarships were given out for the 2021 season
- 788 kids attended swim lessons for the 2021 season
- Planning has already begun for the 2022 season
- A complete resurfacing of the Goodman pool will be starting at the end of September

# Rangers (Joanne Austin):

Although winter activities have not yet started in our Parks, that doesn't mean the work of Rangers has slowed down. On the contrary, with this unseasonably warm weather Rangers continue to patrol and make connections with park users all around the city. Throughout the year, Rangers educate park users about Park Rules and City Ordinances and then enforce when necessary. All permanent ranger positions will be filled by mid-January. The Team looks forward to a busy 2022 season in the parks.

### **Dog Parks:**

Having had more than a full year of allowing leashed dogs in most parks, some users are still not aware that dogs must have both a valid license and Park Permit. The Board of Park Commissioners approved recent changes to the dog status at some parks at their November meeting. Immediately following the approval of this item, our website was updated, Rangers updated signs in parks and clearly marked the "dog-free" parks. Permits can easily be purchased online and signs with the web link, including QR readers for each type of permit, are provided at every off-leash dog park. For Parks that had recent changes, Rangers are educating dog owners through the month of December and will begin enforcement in January. In 2021 alone, Rangers made nearly 400 dog user contacts. Some of these resulted in warnings and others were issued citations.



### Lake Access Signs:

Adequate and useful signage for Lake Access parking and permit requirement clarity has been a work in progress for quite some time. Nearly 100 additional signs were made by Traffic Engineering and Rangers have been strategically placing them at our boat launch parking lots. These signs clarify the need for a valid permit and indicate where to appropriately park (single stalls and trailered stalls). We hope to have this project completed before spring when the launches are heavily used.

### **Homeless Contacts:**

The TPE at Reindahl Park kept Rangers and other Parks staff busy throughout the summer, especially in the last few weeks when the TPE came to an end. With the amazing efforts of outreach resources and numerous City agencies (including Park Rangers and East Parks Operations), those temporarily staying at Reindahl were moved to alternate shelter locations. The Park shelter and athletic fields are expected to be heavily reserved in 2022 and Rangers look forward to providing a positive presence at Reindahl this summer. Although the TPE at Reindahl came to an end, there are still many who are experiencing homelessness throughout the parks system. Rangers will continue to show compassion with everyone. When communicating with any park user that is experiencing homelessness, Rangers will explain the park rules and will get contact information from them. All of these contacts will be shared with CDD and Catalyst for Change outreach resources. In 2021, Rangers made approximately 517 separate homeless contacts.

## Warner Park Community Recreation Center (Terrence Thompson):

The WPCRC had an excellent 2021 after being closed for 10-months in 2020 to support the temporary men's shelter. After reopening on January 25, 2021, the WPCRC was one of the only public facilities in the City offering in-person recreational opportunities, including fitness center workouts, open gyms, facility rentals, and limited community programming at the time. Most notably, WPCRC staff were instrumental in providing programs and services to teens that had been significantly impacted across the City by COVID-19, with the community's focus on virtual support for students K-5. The KNOW Program partnership with the Madison Parks Foundation provided 1,075 hours of afterschool and out-of-school time programs and open gyms for 150 BIPOC teens. Additionally, the WPCRC provided 1,110 hours of adult open gym, providing adults opportunities to stay active and connect with their friends through recreational play.

WPCRC staff displayed an extraordinary commitment to public service in 2021, implementing multiple iterations of the Forward Dane order to ensure community safety during the pandemic without a single reported COVID-19 case. For their efforts, WPCRC staff were recognized by the Northside Planning Council as the 2021 High Impact Award recipient, recognizing significant community impacts for COVID-19 response. Additionally, Mayor Satya Rhodes-Conway selected WPCRC Maintenance Mechanic Chad Norquist to receive a #TeamCity Award on January 5, 2022. The #TeamCity Awards celebrates the great public servants of the City of Madison on a bimonthly basis, recognizing employees that go above and beyond the call of duty and embody the City's mission, vision, and values.
