

- Youth employment expansion opportunities for Summer 2021, Fall 2021 and Summer 2022
- Structured drop-in summer activities for youth in City parks and promote social-emotional development and reengagement.

- Food insecurity
- Legal assistance
- Workplace safety
- Housing

- Language barriers
- Transportation
- Navigating the Health Care system
- Financial hardship

Services to Undocumented Residents

Community Partner/Stakeholder Input

Recommendations

- Legal assistance and Housing are the biggest priorities/needs of this population
- Flexible funding – allowing organizations to meet family self-identified financial needs and reimburse families excluded from government programs
- Be more intentional about considering needs of all populations, not just the Latinx population. Specifically:
 - Southeast Asian and South Asian
 - African
 - Middle Eastern
- Encourage inter-agency collaborations and consider the network of providers beyond individual agencies.

Overview and Guidelines

Target Population

City of Madison residents whose legal status generally limits their access to public benefits. This might include:

- People without lawful permanent residence
- DACA recipients
- Temporary visa holders
- Others who do not fit within the “qualified immigrants” criteria

Scope of Services

- Direct financial assistance/cash transfers
- Legal assistance
- Transportation
- Utility bills
- Job training assistance
- Language learning
- Other needs identified by the resident

January 28, 2022	Application Deadline
February 4, 2022	Staff Recommendations Finalized
February 22, 2022	Introduced at Common Council
February 23, 2022	CSC Reviews and Approves Recommendations
February 28, 2022	Finance Committee Reviews and Approves Recommendations
March 1, 2022	Common Council Approves Final Recommendations
March 2, 2022	Notification of Awards
March 15, 2022	Earliest Anticipated Contract Start Date
