

#### UPDATE ON 2021 ROOM TAX FUND CONDITION AND 2022 ROOM TAX FORECAST

#### 2021 BETTER THAN PREVIOUSLY FORECAST; SETS HIGHER BASE FOR 2022



- Ath quarter collections up 326% from 2020; Y-over-Y up 109%
- 2021 Actual -- \$12.3m vs.
   \$9m in June (used for 2021 transfers to RTF)
- 2022 forecast -- \$17m to \$17.7m vs. \$14.25m in August (used for 2022 allocations)

# IMPLICATIONS FOR 2022 - GOOD NEWS!

- Room tax collections could be 20% higher than amounts used to set allocations in 2022.
- No need for \$2.4 million transfer from TID 25 surplus to RTF (2021 YE Appropriation Res authorized transfer to General Fund if not needed in RTF).
- No room tax revenues were transferred to the General Fund in 2021 – a \$3.7 million benefit to the RTF based on 2021 collections. 2020 to 2022 GF help to RTF – over \$6 million.
- Ending balance for 2021 may have a \$1.2 million surplus (reflects no transfer from the TID 25 surplus to the RTF).
- Ending balance for 2022 could reach \$3 million (includes 2021 ending balance); 30% transfer to General Fund will increase from \$4.2 million to \$5 million.

- × Financial and Program Goals
  - Re-investing in tourism-related programs
  - + Maintaining reserves there really is a "rainy day"
- × 2022 Actual Collections

- × City Budget Process
