





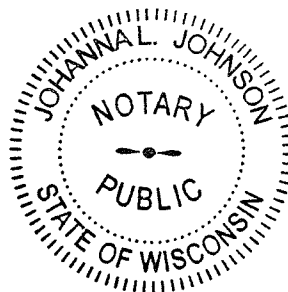

To: City of Madison Property Owners along Worthington Avenue, Powers Avenue, and Thurber Avenue

Re: Proposed Sanitary Sewer Replacement Project & Public Hearing

The City of Madison is proposing to replace the sanitary sewer main and laterals on Worthington Ave., from Rethke Ave. to Powers Ave., on Powers Ave., from Worthington Ave. to Thurber Ave., and on Thurber, from Powers Ave. to N. Fair Oaks Ave., in the summer of 2022. The sewer mains being replaced are owned and maintained by the City of Madison. The City and Town entered into an Intergovernmental Agreement in 2017 when the City acquired the sewer facilities from the Waunona Sanitary District #2. With the agreement, the City of Madison has the ability to assess sewer improvements in the same way that sewer replacements may be assessed on projects within the City. While there is no assessment for the sewer main replacement, there are assessments related to the sewer lateral replacements. In accordance with the City of Madison Assessment policy, the City assesses 25% of the cost of the sewer lateral replacement in the public right of way, when done in conjunction with a City construction project.

Included is a preliminary Schedule of Assessments, which shows the estimated costs for your property adjacent to the project. The Schedule of Assessments for all properties adjacent to the project is available on the project webpage at: <https://www.cityofmadison.com/WorthingtonPowersThurber>; a hard copy can be mailed to you upon request. After the work is complete, a final assessment will be calculated based on bid prices and work actually performed. The final assessment, which will be billed after the completion of the project, is payable in one lump sum or over a period of 8 years, with 2% interest charged on the unpaid balance.

Also enclosed with this letter is a fact sheet with some details on the proposed project, which includes a map of the proposed project limits.

Finally, enclosed is a notification for the Public Hearing before the Board of Public Works. The date, time and location of the public hearing can be found on the notification.

Fact and Details Sheet

Proposed 2022 Worthington Ave, Powers Ave, and Thurber Ave Sanitary Sewer Replacement Project

Project Details – Proposed Work

Streets: No street work is proposed with this project. Where disturbed by sanitary sewer installation, asphalt surface shall be restored with an asphalt patch. The Town of Blooming Grove is planning a street resurfacing project following the installation of the sewer.

Sanitary Sewer: Existing sewer mains are 12” diameter, reinforced concrete pipe, installed around 1951. The mains will be replaced with a combination of 8”, 10” & 15” PVC pipe, and the laterals will also be replaced with 6” PVC pipe from the main to a point 5’ from the edge of the street surface (*laterals are assessable*). The City acquired these sewer facilities in 2017 from the Waunona Sanitary District #2 and also have an intergovernmental agreement with the Town of Blooming Grove for assessing benefits to properties.

Water Main: No work is proposed with this project.

Storm Sewer: No Work is proposed with this project.

Terraces: The terrace is the existing space between the street and property line. This area will be disturbed with the project when sanitary sewer laterals are installed. Locations of existing laterals will be marked prior to the start of construction. If you have any landscaping or items within 6’ on either side of the marked lateral that you wish to save, please remove it prior to the start of construction.

Tree Removals: No trees will be removed as part of this project.

Private Trees: There are a number of trees on private property that overhang the street or generally into the right-of-way. City Forestry will not prune trees on private property. To avoid damage to the trees, property owners should make sure that all trees are pruned up to the required clearances prior to the start of construction, which is 13’-6” over streets and is also our recommendation for any trees overhanging the right-of-way.

Driveways: Driveways will be patched but not replaced with the project.

Construction Schedule & Impacts

Tentative Schedule: This project is currently scheduled to be bid April 28, 2022 and construction is expected to begin in early-July, 2022 and completed in early September, 2022. During construction, the allowed work hours are 7AM-7PM (Mon-Sat) and 10AM-7PM (Sun).

Traffic Impacts: During construction, the streets will be closed to thru traffic (open to local traffic only). Access will remain open to driveways for the majority of the project, but access will be difficult or unavailable when work is taking place immediately in front of the driveways; Residential driveways may be closed for approximately 2 days. Residents may park in street within the project limits during non-work hours but vehicles must be moved by 7AM each morning.

Refuse & Mail Collection: Refuse and mail collection will continue as they typically do, and the contractor will be required to provide that access. Please mark your address on your carts in case the contractor needs to move them for collection.
