You may get an unlimited number of temporary licenses for Beer, but only two licenses for

wine each twelve months.

If your plans include using the street for your event, you will need a Street Use Permit and you
must apply at least 60 days before your event.

At least one licensed bartender must be present.

The fee is \$10 for beer and/or wine per event – events may have consecutive days.
