RE: Consideration of a demolition permit at 734 E Washington Avenue. (ID <u>69794</u>, LNDUSE-2022-00018)

Dear Pat McCabe:

On April 11, 2022, the Plan Commission found the standards met and **conditionally approved** your demolition permit to raze a two-story warehouse at 734 E Washington Avenue. In order to receive final approval of the demolition permit and for any other permits that may need to be issued for your project, the following conditions shall be met:

- Section 28.185(9) requires that every applicant for a demolition or removal approval that requires approval by the Plan Commission is required to get a Reuse and Recycling Plan approved by the City Recycling Coordinator, Bryan Johnson at streets@cityofmadison.com prior to receiving a raze permit. Every person who is required to submit a reuse and recycling plan pursuant to Section 28.185(9) shall submit documents showing compliance with the plan within sixty (60) days of completion of demolition. A demolition or removal permit is valid for one (1) year from the date of the Plan Commission.
- 2. Approval of the demolition permit will require the removal of all structures including the commercial building and parking lot. The driveway apron shall be removed and replaced with curb and gutter as per City of Madison Engineering and Traffic Engineering requirements. During demolition and prior to curb and gutter, barriers shall be installed across the driveways to prevent the parking of vehicles. Disturbed areas shall be graded and seeded or sod planted to minimize erosion.

3. Obtain a Street Terrace permit for the proposed work (installation of the driveway apron,

landscaping, etc.) This permit application is available and must be completed on line at http://www.cityofmadison.com/engineering/permits.cfm (MGO 10.08)

- 4. Obtain a permanent sewer plug permit for each existing sanitary sewer lateral serving a property that is not to be reused and a temporary sewer plug permit for each sewer lateral that is to be reused by the development. The procedures and fee schedule is available online at http://www.cityofmadison.com/engineering/permits.cfm. (MGO CH 35.02(14))
- 5. An Erosion Control Permit is required for this project. See Storm comments for permit specific details and requirements.
- 6. This project will disturb 4,000 sf or more of land area and require an Erosion Control Permit. Submit the Erosion Control Permit Application (with USLE calculations and associated fee) to Megan Eberhardt (west) at meberhardt@cityofmadison.com, or Daniel Olivares (east) at daolivares@cityofmadison.com, for approval. The permit application can be found on City Engineering's website at http://www.cityofmadison.com/engineering/Permits.cfm.

Please contact Jeffrey Quamme of the Engineering Division – Mapping Section at (608) 266-4097 if you have any questions regarding the following three (3) items:

- 7. Identify on the plans the lot and block numbers of recorded Plat.
- 8. The demolition plans shall include all lot/ownership lines, existing building and pavement demolitions, sewer and water connections noting those to be disconnected, and limits of all pavements to remain within the site.
- 9. Provide a full and complete legal description of the site or property being subjected to this application on the site plan.

10. All existing driveway approaches on which are to be abandoned shall be removed and replaced with curb and gutter and noted on the plan.

12. The Madison Water Utility shall be notified to remove the water meter at least two working days prior to demolition. Contact the Water Utility Meter Department at (608) 266-4765 to schedule the meter removal appointment.

Please now follow the procedures listed below for obtaining your demolition:

- After the plans have been revised per the above conditions, please submit one (1) complete digital plan set in PDF format of complete, fully dimensioned, and to-scale plans; the appropriate site plan review application and <u>site plan review fee pursuant to Section 28.206</u> of the Zoning Code; and any other documentation requested herein to the Zoning Administrator at <u>zoning@cityofmadison.com</u>. (Note that that an individual email cannot exceed 20MB and it is the responsibility of the applicant to present files in a manner that can be accepted. Please email <u>zoning@cityofmadison.com</u> regarding questions or if you need alternative filing options. The check for the site plan review fee shall be mailed to the City of Madison Building Inspection Division; PO Box 2984; Madison, WI 53701-2984.) The sets of final revised plans or documents will be circulated by Zoning staff to the City department staff listed above for their final approval.
- 2. This letter shall be signed by the applicant to acknowledge the conditions of approval and returned to the Zoning Administrator when requesting conditional use approval.
- 3. A demolition or removal permit is valid for one (1) year from the date of the Plan Commission. Where the plans have not been altered since issuance of the demolition or removal permit and the permit has expired, the Director of Planning and Community and Economic Development may, after consultation with the Alderperson of the District, approve an extension for up to 24 months from the expiration date.
