The stockroom equals 2,155 sq. ft. and includes two (2) restrooms, one of which is accessible to customers. The stockroom also contains the manager's office. The sales floor occupies 7,801 sq. ft. There are no living quarters. Alcoholic beverages will be displayed for sale in the coolers near the front of the store, and any beverages that cannot fit in the cooler will be stored in the stockroom. Sales records for this store will be maintained at the corporate office in Chesapeake, Virginia.
