VELDRAN stated there will be no meeting next month. There will be County Board Elections and new appointments. He said one supervisor will be replaced. According to the County Board rules if no one is appointed by the May meeting, the present County Board Supervisor will remain on the board committee until the new person is appointed. VELDRAN further explained the process. The Specialized Transportation Commission meetings are going to remain the third Thursday of the month.

BROWN stated he verified with the County Board Office, up until June the meetings will remain virtual.

BRUNES questioned whether the meetings had to be either virtual or in person or can it be both. VELDRAN said the Board is working on a hybrid model. He mentioning doing a Doodle Poll in the coming weeks.

LYMAN is concerned with the hybrid meeting in terms of the recording and attributing comments to correct individuals. If some people are in a room and others remotely the technology in the room needs to differentiate the people from each other.

WEGLEITNER said the third floor committee meeting rooms and Room 201 will be outfitted with all hybrid technology in April. She said Dane County Division of Information Management will be updating all of the conference rooms throughout the County. This should be completed by the end of 2022.

#### D. Presentations

 Mike Cechvala, City of Madison Transportation Planner Madison Metro Transit Network Redesign Plan

Mike Cechvala had another engagement regarding transportation. Ben Lyman did the presentation. Lyman presented an update as to where they are in the process with the redesigning of the Metro Transit Network. They are looking at reallocating resources by reducing the number of routes but increasing the frequency of the buses on those routes. The hope is to have this go before the Council and get adopted this summer.

2. Great Lakes Dryhootch

Joel is the Transportation Manager for Great Lakes Dryhootch in Dane County. He said his primary service is to veterans, especially to those who are medically needy. He also does Section 8 Food Pantry runs.

Supervisor DOOLAN asked what the County could do to best support this program. Joel said he could use help with the fuel cost and possibly a smaller vehicle.

Supervisor VELDRAN informed Joel they should get in touch at a later date to discuss this.

LYMAN said he has funding that hasn't been spent and it is for operations that would cover gas and salary costs. He would need an application in this next round of Section 5310 programming. LYMAN felt that reporting can be a barrier and mentioned partnering with Dane County.

VELDRAN suggested connecting with Campbell and Brown for further discussion on this.
