As I have been told repeatedly, the OMSAP is merely a guide, a vision. The original road map design is not appropriate for what is needed in this area. We don't need a main thoroughfare, which would allow for fast traffic trying to avoid the main arteries of transportation on the Northside. A main through street would be dangerous to put in the middle of senior and low income housing development as well as negatively affect local businesses and the natural conservancy. The City is ignoring the developer's and community's wishes. This new proposed road would save at least 15 of the originally promised 16 acres of conservancy which the City's original design has wheedled down to under 13 acres. The new street alignment would protect the ecologically and aesthetically important mature tree line which currently has many healthy large trees that support natural area biodiversity and sustainability. Although it may look messy, a conservancy is not supposed to look like a golf course. The birds and animals which the old tree line supports need that area because it provides critical shelter, habitat and food source. 2) No impairment of the ecological functions of the area's wetlands.

- * No erosion during or after construction
- * No toxic runoff from the roads, including road salt.
- * No change in the wetland's surface water inflows and outflows.

Any road that cannot meet these minimal criteria is not worth building.

The Joint Staff Report on Legistar 69519, dated June 3, 2022, falsely says that the Oscar Mayer Special Area Plan, provides "an ample amount of future open space given the anticipated number of new housing units." 

City planning staff have chosen to ignore broad community support to Save All 30 Acres at Hartmeyer Natural Area. They have tried to claw back on the Madison Common Council compromise vote to save at least 16 acres.

Clty planning staff have also chosen to ignore the developer's wishes, broad public support, and environmental concerns to minimize new streets and save the only large grove of mature trees in the new CN Nature Conservation park. In fact the city planning staff proposed street mapping and zoning plan would wipe out almost the entire tree line.

The city planning staff proposed street mapping would not be safer because it would route traffic from North Sherman right through the middle of senior and low income housing and the new quiet nature park instead of using the existing major streets at Aberg and Commercial. We don't need to pave every inch of open space.

Please make a motion and vote for the Developer proposed and Community supported Substitute Street Mapping that saves at least 15 CN Park acres including the only large grove of mature trees in our new nature park.

Minimizing impervious surfaces and saving a sustainable and biodiverse CN Conservation Nature Park with minimal new streets will help address Madison's climate, carbon and clean water goals as well as equitable safe walkable access to nature, public health, and this environmental gem. The Substitute Street Mapping and CN Zoning is a true WIN-WIN for both the city and the community.
