New initiatives:

Carts in Parks 2.0 – The pilot program is going well. We are beginning to add fall events.

1. Parks Alive

Parks Alive 2022, a collaborative effort across multiple City departments and a wide-variety of community-based stakeholders and mobile resources, included 30 events in 8 parks (in or adjacent to NRT neighborhoods) and provided opportunities for more than 1000 residents to enjoy their neighborhood parks, build community, strengthen relationships, and have fun! Events were held at the following parks: Aldo Leopold, Allied, Warner (by Brentwood), Elver, Meadowood, Owl Creek, Penn and Worthington.

Sidewalk Cafes & Roadway Café:

Applications submitted - 78

- 24 applicants are requesting use of the parking lane.
- 13 are city-wide
- 65 are in the Mall/Concourse

Ongoing Business:

- We are preparing for the 2022 Fall Food Cart Review. The 2022 review will take place 9/12-10/9. Food Cart Reviewer Training took place on 8/30/22.
- Staff will work with the BID and GSSBA to review Art & Craft vending sites for 2023. A draft of these changes will be shared at a future VOC meeting.

City of Madison Vending Oversight Committee Meeting Street Vending Staff Report May - August 2022

- Late Night Vending is set to end in 2023 if a new program is not designed. COVID derailed that planning process. The VOC will need to review any changes to this plan currently outlined in Ordinance.
- Taste of Madison organizers have asked to have Art & Craft vendors stay for the full event on Saturday and not leave early. This is the first time in the 40-year event history this has been an option. The majority of licensed vendors have agreed to stay from 7:30a-8:30p on 9/3.
