MOTION TO ADOPT 2023 ROOM TAX COMMISSION BUDGET

Motion:

Move to adopt the 2023 Room Tax Commission budget, as follows:

- 1. Estimate 2023 room tax revenues of \$19,000,000 (12% increase over estimated 2022 revenues of \$17,000,000)
- 2. Allocate \$6,680,038 of room tax to Monona Terrace, as follows:
 - Operating subsidy of \$4,825,725
 - Capital purchases allocation of \$1,655,000 (the 2023 executive capital budget will include \$1,655,000 Room Tax Fund-supported GO borrowing for Monona Terrace capital projects)
 - Debt service estimate of \$199,913 for previously issued Room Tax Fund-supported GO debt issued for Monona Terrace capital projects
- 3. Allocate \$2,095,000 of room tax to Overture Center
- 4. Allocate \$738,152 for the Alliant Energy Center, Olbrich Botanical Gardens and Henry Vilas Zoo, as follows:
 - a. Alliant Energy Center -- \$95,800 (Dane County)
 - b. Olbrich Botanical Gardens -- \$317,352 (City of Madison)
 - c. Henry Vilas Zoo -- \$325,000 (City of Madison operating contribution)
- 5. Allocate \$5,539,037 of room tax to Destination Madison, as follows:
 - \$5,264,037 for destination marketing
 - \$275,000 for event booking assistance subsidy
- 6. Allocate \$177,500 of room tax to City Tourism Marketing, as follows:
 - Sister Cities \$30,000
 - Music -- \$55,000 (\$25k for Dane Dances and \$30k for Make Music Madison)
 - Art/Fests -- \$17,500
 - Blink+ -- \$30,000
 - Implementation of Music Tourism Economic Recovery Plan -- \$25,000
 - WIAA Tournament -- \$15,000
 - Civic Promotion/Civic Conferences -- \$50,000
- 7. Allocate room tax for administration and enforcement, as follows
 - Administration -- \$20,000
 - Enforcement -- \$15,000

Note: Under this motion, after transferring 30 percent of 2023 room tax revenues to the General Fund (\$5,700,000), the estimated balance in the Room Tax Fund on December 31, 2023, would be \$361,514, which is 2.36% of 2023 revenues. On-going expenditures (including Monona Terrace capital allocations) exceed on-going revenues by \$2 million.
