We are very pleased to provide you with this proposal to amend our professional services. When accepted, this proposal will amend our Agreement dated April 18, 2022.

This proposal is for Village on Park Parking Structure (Project). This proposal is subject to contract between the Community Development Authority of the City of Madison (CDA) and Graef-USA Inc. dated April 18, 2022.

The original scope and fee was based on a precast parking deck with the precast parking deck structural components being designed by the precast manufacturer and GRAEF providing structural design of foundations. After review with CDA and GRAEF team, a post-tensioned flat plate is being recommended due to a number of factors:

- Precast currently has a 14 month lead time during construction
- Flat plate costs are slightly higher initial costs but could have cost savings during construction due to long lead time for precast.
- The depth of flat plate system is less (approximate 24 inches per floor) resulting in lower overall height of parking deck.

GRAEF will be providing the engineering/design of above grade structural post-tensioned parking levels for 295 car parking deck with six & half (6.5) structural levels above grade.

For this Project, GRAEF proposes to provide the following additional Basic Services:

 Engineering/design of all above grade structural post-tension parking levels for 295 car parking deck with six & half (6.5) structural levels above grade. Includes stamped structural calculations, structural plans, details and specifications for structural post-tension parking levels.

GRAEF will endeavor to perform the proposed additional Basic Services in accordance with a mutually agreed-upon schedule.



You agree to compensate GRAEF for all additional Basic Services noted above with an additional sum of \$50,000. Our breakdown includes:
