I am Ester Lowery, a resident of Second Addition of Sauk Creek Estate, Madison, WI. <u>Position:</u> I would like to state the position to keep the status of Haen Family Park as "DOG FREE", and <u>against the request</u> to change it to a dog friendly park.

My spouse and I have resided in the neighborhood and have used Haen Family Park for more than 30 years. It is a relatively small park that serves a large area of residents. Our children used the park during their younger years and now our grandson uses the park on a very regular basis. This park has been a very enjoyable experience of not having to be concerned about him or us accidently stepping into dog feces or having well-intended dog owners allowing their dogs to run free or leash. I live in the neighborhood, and I feel that neighbors will continue to treat the park as they do my front and backyard. We do not have a dog, yet we must regularly clean dog feces from our yard and replace decorative chips around the mailbox as recently as this first week of November 2022.

Each winter when snow is available, we use the park to cross-country ski around the parameters of the park. Once the ski tracks are made in the snow, almost without fail, a park user with their dog(s) will walk the trail over the ski trail tracks and the dog will have deposited feces on the ski tracks. These feces cause us irritation to have to try to ski around dog feces. This is quite frustrating. These hikers already are aware that dogs are not allowed in the park, but they ignore the rules and are already using the park and depositing feces that are left behind. With the proposed status changed to pet-friendly, this will surely cause more feces left behind by well-intended dog owners.

I am very concerned that when our grandson runs through the park, there will be encounters with dog feces that he will not see or recognize and step in these messes. We would have to closely monitor where he places his feet for fear of stepping in dog feces.

Over the years, Haen Family Park has grown to become a heavily used park by adults, youth and small children during the spring, summer, and early fall. It is my estimate that there could be as many as 200 people some evenings sharing this readily small space for games and fun activities. At times the entire park is being occupied by people. This proposed status change with such a large number of people could potentially cause some overreacting responses by dogs towards adults and children of which would mostly not be appreciated. I am aware that there are some Pitbull dogs in the neighborhood, and by their own nature can be aggressive and intimidating. I am concerned that these loving dogs could display aggressive behavior towards other Individuals. My own experience has been that individuals who own dogs as pets tend to think everyone loves their dogs and fail to appreciate that their behavior needs to be restricted around other people. I am concerned that these dogs will cause distress for my grandson and myself as well as dog feces litter on the play

area and ski trails to a greater degree. I am also concerned that the conversion to a dog friendly park will attract dog owners from other neighborhoods to use this limited space thereby orientating the park as a dog park rather than people-oriented park as it is currently being used.

Again, I would like to state my position, to keep the status of Haen Family Park as "DOG FREE", and against the request to change it to a pet friendly park.
