Dear Board of Parks Commissioners,

I am writing about the proposal to switch Hawthorne Park to a dog free park. We absolutely need a place on the isthmus, especially in the near east neighborhoods, that is dog free and safe from the dangers of being chased, harassed, knocked over, and attacked by dogs. Hawthorne Park is incredibly small, which is certainly in keeping with your decision to designate only the smallest possible isthmus parks as dog free.

Its small size, much of which is used by the playground and basketball court, makes it very hard for there to be a safe space to play and relax if dogs are there. On top of that, the steep slope on the Rusk St side makes it very hard not to fall down when dogs chase or jump on innocent parkgoers.

However, the designation as a dog free park is a completely empty gesture unless there is actual enforcement of the no dogs allowed rule. Why would an on-paper "dog free" Hawthorne Park be any different from Morrison, BB Clarke, and Elmside Circle- all supposedly dog free parks that are routinely overrun by dogs on and off leash? I have tried over and over to go to these parks to try to relax safely outdoors, but I have never once been able to stay more than 15 minutes without being harassed by an off leash dog. I can pretend to ignore the leashed dogs most of the time, but as a disabled person with mobility and balance issues, the huge number of off leash dogs that chase, jump on me, and knock me down presents a serious danger and makes going to the park stressful and scary. Asking people to leash their dog or remove it altogether is usually just ignored, although I am also often cursed out or interrogated about where I live and if I actually "belong" in the neighborhood.

What would you do to make Hawthorne Park any safer? Will there be park rangers there actually enforcing the rules? Even a weekly visit or a special enforcement efforts a few times a year (like speeding enforcement campaigns) could make a difference. For six years I have been visiting isthmus parks several times a week, and I have never once seen a park ranger at a park. Calling and emailing doesn't help, since they almost never respond. If not enforcement, what will you do? Will you create an outreach campaign with animal shelters and veterinarians to reach dog owners who don't understand why we need the dog rules? Will you create a media campaign to share stories and statistics about the dangers of having dogs, especially off leash dogs, running wild in parks- dangers to the dogs and to other visitors?

Right now, many dog owners simply don't care about the rules because they know there is absolutely no enforcement of dog free or leash rules, and because there is no societal pressure or encouragement in Madison helping them understand other people's very real concerns. Unless the Parks Department does something to address these issues, designating Hawthorne Park or any other park as dog free is just a pointless action that in no way provides a safe place for people to recreate without dogs.

So sure, it would be amazing to have a dog free park in the neighborhood, but please understand that will take real action, not just a checkmark on a website.

Dear Board of Park Commissioners:

I received a notice that the Board is considering making Hawthorne Park dog free. I strongly disagree with this proposal. I have lived in the neighborhood for several years. Aside from early in the morning, there are very few dogs that are ever in the park. And, in the early morning, there is nobody else in the park, except the dogs and their owners. I am struck with how responsible dog owners are in this neighborhood. I have never seen any interaction between a dog and a person -- or between dogs -- that has given me cause for concern. Parks are intended to be used by as many members of the community as possible. It makes no sense to restrict a significant portion of our neighbors from using the park, just because they have their dogs with them.

In fact, rather than restricting dogs from Hawthorne Park altogether, I would urge you to make it more dog friendly. In other cities, dogs can be off-leash in parks during certain early morning hours, like 6-8.30 am. I would urge the Board to consider this allowance for Hawthorne Park. The yards in this neighborhood tend to be quite small and restrict dogs' ability to run around. Although there are dog parks a few miles away, they are not within walking distance. Some residents do not own cars, and it is not feasible for other residents to load their dogs in the car and drive to a dog park before work. Besides, at dog parks, there are many overly aggressive dogs, and the dogs do not know each other. Many dogs only feel comfortable interacting with other dogs they see on a regular basis. This system has worked well in other cities. There is no reason it could not work at Hawthorne Park.

People in the neighborhood seem most likely to interact around the dogs. If I am walking by myself, it is extremely rare that anybody says anything to me. However, if I am walking my dog, several people, from young children, to young adults, to older residents, regularly approach me, asking to say hello to the dog. The presence of dogs helps create a sense of community in our neighborhood, and we should do everything possible to support responsible dog owners, including letting them use Hawthorne Park with their dogs.
