To the Board of Park Commissioners:

I am strongly in favor of retaining the "dog-friendly" designation for Hawthorne Park.

I have lived behind Hawthorne Park for 37 years. I don't have a dog now, but when I did, Hawthorne Park banned dogs. Years ago, it was widely understood that the city had staff patrolling parks and citing anyone who let their dog even step one paw on the park grounds. While it may not have been true, it was a common understanding among dog owners, and it was respected, even if it was resented! It was a very good change for the neighborhood when the city realized the benefits of allowing leashed dogs in Hawthorne and most other parks.

I believe this issue raises two questions for the Commission to consider:

1. First, a concern at the last Commission meeting was that the threshold for considering a change to a dog park designation was too low and presented a burden to staff and the Commission, and set unrealistic expectations for the public. I hope the Commission will resolve this and increase that threshold.

2. Second, as other commenters have mentioned, setting any designation with no hope of enforcing that designation is just a waste of everyone's time. If dogs should be leashed in dog-friendly parks, then there should be some consequence for disregarding that rule. If a park is designated as dog-free, there needs to be enforcement.

Please keep Hawthorne Park dog-friendly!

Dear Commissioners. I am writing to comment regarding your consideration of no longer allowing dogs at Hawthorne Park on Rusk Street. This change would have a significant negative and punitive impact on the families in this neighborhood, some of us who have lived here 20 years or more. I am aware there is one dog owner that lives immediately adjacent to the park (on Rusk) that allows his dog to roam the park off leash and the dog at times can be aggressive toward people, children and other dogs – running at them because it is not on a leash - and it poops in the park and the owner does not clean it up. I believe this neighbor used to have two dogs but only has one now (large bully breed dogs) – not sure. This neighbor has allowed this behavior of his dogs for a long time, even before dogs were allowed into the park, and I believe this consideration/request to remove dogs from the park is mainly aimed at addressing this one person's and his dog's behavior. The rest of the neighborhood, and the families with dogs, should not be punished and deprived of their ability to fully use the park for their entire family, including the fur members of their families. The City should, instead, enforce its ordinances against the offending person(s) and dog(s) rather than punishing all of us.

Hawthorne Park is a place where families and their dogs get together as a neighborhood to meet one another, interact, play and have fun. Many more people have used the park, making it safer and more friendly, since dogs have been allowed to visit the park with their humans (we used to find needles and used condoms in the park, and we have not seen those things since more people and their dogs have been allowed in the park). Not only would this change penalize the families – especially the kids – that enjoy the park because of the actions of one or even a few, it will not solve the problem. Board of Parks Commissioners,

I live at 142 Division St #3 with my 5 ½ year old dog Piper. She is gentle to everyone, shy and sweet, and adored by children and adults. Hawthorne Park is everything to her. Her friends are there, human and dog. In a neighborhood with dangerous high-traffic streets, the park keeps my dog safe. If I were to ever lose her, I'd know where to look. Almost any neighbor would know who to return her to and how to find me.

Concerns about dogs off leash, dog poop, and dog behavior are not problems with dogs. They are enforcement issues for their humans. Even if true, they do not rise to a reasonable standard for a policy change. Dog free parks are available for people afraid of dogs or who want a dog free outdoor place to relax. Changing the status of Hawthorne Park would exacerbate an existing deficit of dog friendly parks.

Dog owners pick up others dog poop and trash and keep the park clean. Dog owners use the park throughout the day and help keep the park safe. Dog owners yield to other park users and don't use the park when people have events. There are no known incidents of dog human conflict or with shared use of the park. Concerns are not borne out by evidence. There are no known warnings or tickets issued for off leash dogs, no dog bites, no police calls, and no harm.

The BPC should provide criteria and standards for changing the status of a park in either direction of dog free or friendly. Examples or times changes were previously made should be shared with the reasoning for those decisions. No criteria, standards, or examples are found in the city or park websites and publications. Residents deserve to know how the BPC makes its decision. This proposed change is widely perceived as a surprise without precipitating incident. The Parks website states they use education then enforcement. This is the education phase. It would be unjust to make a policy change without first having more education and enforcement of existing rules. Just like the F35s, trains, and an overabundance of Thai restaurants, street festivals, enlightened egos, and free-range children, dogs are part of this neighborhood and park.

The published comments as of 11/7 are largely in opposition (29-5) to a status change and supportive of keeping Hawthorne a dog friendly park.

Those in favor of a status change have a current remedy of dog free parks including Elmside Circle, Hudson, Morrison, Orton, and BB Clarke within the radius defined in the 2019 long range committee study materials. In the same area, only Olbrich, Yahara Place, and Hawthorne are dog friendly. Dog parks at Commercial and Demetral are not frequented by neighbors since they are farther to walk to and East Washington Ave is a barrier to safe pedestrian traffic. Most parks in the isthmus are already dog free. Dog friendly parks receive greater use when there are fewer options overall.

Those opposed to a status change speak to the vibrancy and health of the neighborhood as it is improved by having a dog friendly park. Repeated comments praise the conscientiousness, cleanliness, and considerate behavior of dog owners overall. Many kids come to the park with their dogs or to see dogs. Adults who are afraid for the children should listen to them. They are not afraid, including the 8- and 9-year-olds who commented opposed. Dogs help acclimate kids to being around them. Kids who grow up with dogs get the same benefits from their companionship as adults. Parents with young kids and dogs use the park with their whole family and rightfully want to continue to do so.

Some neighbors don't like dogs and still oppose a status change. They rightfully don't want to harsh other neighbors mellow. It's not Wisconsin nice. Hawthorne Park is a safe haven for all. Dogs need a place to exercise, and the pandemic increased the number of dog owners in the neighborhood. With an existing deficit of dog friendly parks, why would the BPC want to make people drive more or exercise less?

The dogs are so well-behaved and watched over that people bring cats on leash to use the park at the same time as dogs are there.

Take a look around the room at the snapshot of this neighborhood as you hear the stories of our community at Hawthorne Park. It is probably the only time you'll see any of us without our dogs. Since you probably won't get to meet our dogs like we have, you should know their names and understand the impact of a status change on them and us.

There are a lot of dogs missing their owners during the hearing.

Piper. Helmut. Lena. Nita. Pickles.

These dogs aren't doing anything wrong.

Drizzy. Pip. Cody. Harper. Norman.

These dogs are living their best lives and showing us how to do the same.

Lily. Paul. Mary. Stella. Marcy.

These dogs are lifelines to our community. They are a refuge from work, stress, and problems. They get us outside talking to each other.

Ava. Apollo. Elliot. Ollie. Coco.

These dogs have friendships built with each other and human owners and neighbors. In Hawthorne Park. For years.

Frankie. Nahla. Bessie. Geoffrey. Paul (two Pauls and neither is a walrus).

How do you tell these dogs that their park was taken away? They will still want to go there and miss their friends. That's not something you can untrain. It will create depression and obesity for them.

How do you tell kids that dogs were taken away from their park? That will give them depression too.

Children, dogs, all of us are living in hard times. Don't needlessly alarm the neighborhood and make hard times worse. Educate and enforce the existing rules. Hawthorne Park reflects the neighborhood now as is and should remain dog friendly.
