Hello Madison BPC,

My family lives a stone's throw from the Forest Hill Cemetery and occasionally goes on walks through the grounds. We love the peace and history of the walks, and lack of motorized vehicles to dodge. On walks we bring our baby stroller and our small dog on leash, who loves looking for squirrels she cannot actually chase. We always pick up our dog's poo and have never seen dogs off leash with other humans on the grounds.

We consider this walking route a benefit and amenity of living in this neighborhood. While house hunting, we passed on several homes that abutted to nice conservancies (notably Owen) because we would not be able to take our dog along while walking through them, even on leash. We respectfully ask that the decision makers continue to allow leashed dogs in the FH cemetery and if necessary, take intermediate actions to cut down on off leash dogs in the cemetery which again, we have yet to see in our first year living in this neighborhood. Our impression is that humans and dogs are respectful of the cemetary's legacy and landscaping - and we consider it an honor to be a part of that. If anything should be adjusted, we would suggest more patrol presence for vehicles hanging out in the cemetery toward dusk that don't seem to have a

cemetary related reason for being there. Perhaps this action would also cut down on possible off leash dogs.

Dear Parks Commission Colleagues,

I wish to formally request herein that the current status of Forest Hill Cemetery as a Dog-Friendly park be retained. This park provides a beautiful, peaceful, quiet and most importantly, safe location in which to walk dogs on leash (on roadway only) for families nearby. While I can certainly sympathize with those select people who have difficulties being in the presence of dogs or have witnessed dogs being off leash or being permitted in cemetery regions not currently permitted, it is my contention that a blanket "Dogs Prohibited" status is not going to reconcile such problems and will really only punish those of us who follow the rules and respect the sacred grounds within the cemetery. Individuals that do not respect the current rules stated (dogs on leash on roadways only) will certainly not respect a "no dogs" policy either. In addition, a blanket "no dogs" policy will most likely remove the comforting periodic presence of dogs to those visiting the cemetery (and likely in various states of mourning and/or distress). It is my contention, based on personal experience, that the number of cemetery guests who are somehow comforted by the sight of well cared for dogs in the cemetery probably far exceeds the number of cemetery guests who are unsettled at the sight of said dogs and their owners. In all, I believe that the current Dog-Friendly status of the Forest Hill Cemetery vastly improves the experiences of those walking dogs in the neighborhood and those visiting the cemetery relative to the former Dog-Free status. Relatedly, it should be noted that, the presence of dog walkers in the cemetery provides an increased presence of generally law abiding, anti-polluting and community-minded individuals who might otherwise not be present. Collectively, a Dog-Friendly status has overwhelmingly positive effects for the vast majority of individuals that frequent a given area.

It should also be noted that there are, depending on time of day, significant safety benefits to be considered by having Forest Hill a Dog-Friendly site. Pedestrians traveling along Speedway Ave. are able to use a sidewalk only on one side of this often busy road. Depending on the time of day

and locations involved, it can be very tricky to cross Speedway Ave. in order to access the sidewalk bordering Resurrection Cemetery. By allowing those with dogs to access the Forest Hill Cemetery roadways, pedestrians are offered, at all times of day, a safe way to travel along Speedway Ave. It is highly likely that this consideration, as important as it may be to pedestrians near, but not in, Forest Hill Cemetery, is likely not a consideration to those seeking a banning of dogs within the cemetery. I feel, especially as we head towards winter and the amount of daylight diminishes, this is a factor that Parks Commission members might give considerable thought to.

In sum, I thank all those with input and suggestions for how to move ahead with dog-related policies in Forest Hill Cemetery. Nobody's considerations should be discounted. However, in light of what has been gained by the current Dog-Friendly status for the majority of those impacted, it would seem counter productive to revert to earlier Dog Free status.

I do not agree that the requested change to dog free designation for Forest Hills Cemetery is necessary or should be implemented.

I think dogs on a leash in the cemetery are acceptable despite the concern that will be addressed at the 11/9/2022 BPC meeting.

I have a family plot in Forest Hills, Section 40, for the past 14 years. In the summer I water my plants 2 - 3 times/week during the day time. While watering I often see people

walking on roads in the cemetery, but very rarely with a dog. The rare evening that I have walked in the cemetery I have not seen a dog.

My daughter has a very nervous and anxious dog. Her dog does not tolerate other dogs or unknown people. Her dog will lunge and bark at them. Because the cemetery is quiet with few other dogs, my daughter walks her dog on a leash several times per week on the cemetery roads. She cannot safely walk in areas with lots of people or take her dog to a dog park. She controls her dog on the leash. The only time she allows her dog to walk on the grass or near a grave monument if when people do not give her dog enough space on the roadway.
