I've lived near the cemetery since 1974, since 1977 with dogs. I remember walking with a stroller and our border collie on leash on the cemetery roads in the earlier years—I'm not sure that was actually allowed at the time, but I made a mental calculation that the roads were distinct from the earth portions of cemetery grounds where by Ordinance dogs were not allowed.

In later years with successive golden retrievers I put in time and miles in wintertime with a dog, sometimes off-leash, in the woods bounded by the golf course, the cemetery, and the rail corridor, later the pedestrian-bicycle path (Southwest Path). In that time I sometimes saw a car or cars parked at the far corner of the cemetery using that access to the woods, and sometimes using the cemetery area as an off-leash dog area.

In the time of my most-recent dog we made great use of dog parks, mostly the county ones that allowed the dog lots of running, following scents, and greeting people and other dogs. We also made occasional walks up across the SW path to the area between the path and the cemetery. On one of those walks I saw a sign posted on the chain link fencing of the cemetery indicating that leashed dogs were allowed on paved portions. This was very welcome to me. I resumed leashed dog walking on the paved areas, with the cemetery's reflections of our area's history—oaks, indigenous people's mounds and damage done to them, robust views of how to meaningfully honor buried people, robust or struggling plantings at graves, including peonies that sent me on a search to find the dark red variety that had flourished unattended in the shade for 50-plus years—it is "Kansas"—only to note some years later that someone had captured the plant in a more direct way, stealing 2/3 of it. Well, that's living people for you.

In the later years with dogs allowed on paved roads there have still been people with off-leash dogs in the cemetery.

It seems likely to me that a policy change to "no dogs at all" would be a loss for many without necessarily solving the problems that may have occurred with the leashed-on-paved-areas policy. The dogs come with the above-ground people—people who are mostly respectful, sometimes not, and when not respectful finding many ways of expressing it.

I feel secure walking with a leashed dog, now a borrowed one, in the cemetery, and It is still a happy, quiet experience I would greatly miss.

Dear Commissioners:

Please add me to the list of Regent Neighborhood residents who urge you to continue to allow dog-walking in Forest Hill Cemetery.

My wife and I have lived on the 300 block of Virginia Terrace, directly adjacent to the cemetery, for 38 years. For much of that time we have walked our dogs *on-leash* through the cemetery perhaps once or twice per week. We have rarely seen anyone abusing the leash policy. (In fact, I don't see many other dog-walkers there at all.) If that were a *common* problem, I could understand why you might want to prohibit dogs. Otherwise, why would you do so?

There is no sidewalk on the south side of Speedway Boulevard. If you ban dogs from Forest Hill, walking our dog to the Westmorland neighborhood, as we frequently do, would require us to cross the often-congested five-way intersection near the cemetery entrance, then cross back at the busy intersection of Glenway and Mineral Point. Traversing the cemetery requires no such crossings and is much more appealing, especially on hot summer days when there is no shade along Speedway.

My wife and I have burial plots at Forest Hill. (We also contribute to the Madison Parks Foundation.) Some day we will be laid to rest there. I have no objections to sharing it with future neighborhood residents and their dogs.

Greetings -

I recently received a postcard about dog walking in the cemetery. Although I am involved in the neighborhood, this postcard with the announcement of a proposed ban was the first I had heard any discussion about management questions, concerns, or proposals for the cemetery.

My background -- I live near the cemetary on Rugby Row and walk my pups on leash on the roads in the cemetery 2-4 times a week throughout the year after work/supper time. I have lived in the neighborhood since 1998 and grew up near Hilldale and graduated from West in the 80s. My parents and sister are buried in the cemetery and I enjoy 'visiting' their graves as we walk past frequently. Someday (hopefully far down the road), my wife and I are planning to be buried in the family plot. So, I am a neighbor, an owner of a family plot, and a user.

We normally take a 2 mile walk - +/-45 minutes. In the summer, my wife and I sometimes walk before work - 7-9ish. I have been doing this for several years. I don't remember seeing people in the cemetery with dogs off leash. Most walks, we see a few other walkers and only occasionally others with dogs. We enjoy walking there because it's beautiful, historic, quiet, and a peaceful place to walk without traffic. Something almost always catches my eye or ear on the walk - some family name, unusual monument or the sound or sight of owls, cranes, or oak trees. It's nice to walk there because the roads are wide and there's lots of space for distancing - covid - and also when we pass other walkers with our very friendly dogs, something that's more awkward on narrow sidewalks.

I don't understand what problem this proposal is trying to solve and think that this outright ban is the wrong initial step for the commission to take. Are there reports of unleashed dogs causing problems? Is this related to the woods in the ravine adjacent to the golf course (which I consider part of the golf course campus)? Is this a problem related to the roads in the cemetery? is this a specific conflict/dog issue? Is there an education solution that would be more appropriate? Or perhaps an enforcement issue if there are reports of off leash dogs or a problem dog/owner?

I would ask the Commission to evaluate if there is a more focused change to address a specific problem that I am unaware of? I have seen no problems on my visits to Forest Hill. I see no signs posted telling people to change behaviors.(I do see signs telling us to have dogs on leash). I have not seen a Madison Park Ranger vehicle in the cemetery enforcing current regulations.

The proposal is a significant loss of low impact access to that tremendous asset in our neighborhood. It's ironic and really disappointing that after the substantial public and private investment in the adjacent golf course to try to make more user groups welcome on the golf course land to immediately see this proposed action right next door limiting access.

I strongly oppose this change. If there is a concern or an issue, I believe an initial approach should be education followed by enforcement. It is entirely inappropriate to make this very significant change as a first step.

Dear Park Board Commissioners,

I am writing to give comments on the Forest Hill Cemetery dog park status. My back fence is on the cemetery (I live on the west side of Virginia Terrace) and am very familiar with the dog situation therein. In my view, the main issue could be resolved by extending the sidewalk on the east side of Speedway to connect where it now ends by the golf course clubhouse/bus stop area, down to where it restarts near the cemetery office. Many people in the neighborhood like to walk dogs in a loop that goes down the bike path, up the sidewalk on Glenway street, then around Forest Hill Cemetery, but the only way to do that without crossing and recrossing Speedway and its dangerous intersection at Highland/Regent/Speedway, is to cut through the cemetery.

Most people who cut through the cemetery with dogs keep to the paved roads, which seems OK. But some people do walk over the grass and grave areas with dogs, which many people consider to be disrespectful. In my view, off-road dog walking should not be allowed, but I have not noticed on-road walking to cause problems or heard complaints from neighbors about that.

An alternative to extending the sidewalk might be to simply limit dog walking to one road through the cemetery. The road you can get on by the used-oil collection station near the golf course runs roughly parallel to Speedway most of the way and then another road goes to the cemetery office where the sidewalk starts up again. Putting up a few "designated dog walking route" signs might be cheaper than adding a section of sidewalk.

I recently heard that the Board of Parks Commissioners is considering making Forest Hill Cemetery a dog free park, and I would like to share my strong opposition to this change.

My husband and I adopted our dog Juno, a rescue, from the Dane County Humane Society over four years ago. Unknown to us at the time she turned out to be a nervous and fearful dog. We've worked hard on her training, but due to her past and chronic health issues she is still very nervous about unfamiliar people and dogs. We take her walking 3+ times a week in Forest Hill Cemetery and it is the only place we've found where she's comfortable and is able to have a low stress walk. We love the cemetery because we can easily see other people and dogs in the distance and plan our route accordingly to avoid them. The Cemetery provides a very important quiet, peaceful place for people and dogs who aren't able to frequent other busy parks. I also enjoy walking in the cemetery with Juno because I'm able to visit our family plot and my brother's grave.

We are always careful to keep Juno on the paths and avoid any gravestones or plots. I heard that the concern raised is that some dogs may pee on the headstones, which I agree is inappropriate. Outlawing dogs in this park all together, however, is punishing everyone for a few people's poor behavior. Instead I suggest that we put up signs that remind dog owners to respect the people who are resting in the cemetery and therefore to keep their dogs away from the plots. Good afternoon, I have written to you before with a suggestion for the "development" of Glenway Woods. I would like to add to my comments. I hope you will be willing to read my letter even though it is a bit long.

1- Dog walking is a very inexpensive way for Madison Parks to encourage and provide for many people to get regular exercise. No tennis courts, no golf courses, no expensive maintenance. It is really wonderful that you have opened up many Madison Parks for on leash dog walking. Thank you for that! 2- Besides walking one's dog, responsible dog ownership includes making sure the dog gets to stretch his/her legs and run, get its heart pumping and exercise her/his muscles. Some younger people can run with their dogs but most of us can't! Responsible dog owners try to get their dogs running many times a week if not daily.

3- Currently, people in the Regent and Dudgeon Monroe neighborhoods have to get in their cars to take their dogs to a dog park where dogs can legally be off leash and run. The closest ones are small so the owner can't get a good walk and the larger ones are between 4 and 10 miles away-a substantial time commitment. And all these trips add to the use of fossil fuels and climate change.

4- I suggest running a pilot project that would allow very limited specific times for off leash dog walking at the "new" Glenway Woods. A random example: Tuesday, Thursday and Saturday mornings from 6-8 AM and 6-8 PM ... or any combo! I realize that city ordinance requires dogs to be on a leash but I assume that Madison Parks can approach the Common Council to allow a limited time for them to try out a creative pilot project. Naturally, there would have to be Park Rangers on duty from time to time to give out tickets at the end of the time limit. just as we require already in city parks.

5- I realize that very few Madison dog owners live near an official dog park so I am not suggesting that this is a question of fairness. I am pointing out that this is an OPPORTUNITY to see how very limited off leash dog walking works out in this situation. I understand it is being used in one westside neighborhood park already. We have been walking dogs off leash in Glenway Woods for decades and I do not know if there have been problems. Maybe it would continue to work out really well and we would have a model for other protected parks and other well behaved dogs. Which would encourage more dog walking and less car driving. It could be a win-win.

6- Lastly, by not taking advantage of this unique opportunity to think and act creatively, Madison Parks is requiring dog owners in this neighborhood to make special long trips by car to exercise their dogs.. use more fossil fuels, add to climate change and get less exercise.

Dear Board of Commissioners,

Thank you for collecting neighborhood input on the proposal for dogs within Forest Hill Cemetery. It is my position to maintain Madison General Ordinance 8.195 passed in 2020 to allow leashed dogs on paved roadways within Forest Hill.

The paved roadway extending from the Glen Golf Park parking lot to Regent Street is the only <u>safe</u> parallel pedestrian egress down what is arguably one of our most dangerous streets and aptly-named Speedway Road. There is no safe sidewalk that allows safe passage from Glenway Road to Regent Street.

This path on the northside of Forest Hill property is in effect a sidewalk for pedestrian use.

For every morning the last two years, I have walked my licensed dog Izzy on-leash on the paved pathway as part of our daily exercise. At no point is she allowed off-leash or to use the toilet, or to be anywhere other than walking the road with us within the park. As a neighbor adjacent to this pastoral and historic setting, I take this daily walk as my opportunity to reflect on my contributions and honor those who have come before me, making Madison the great community it is today. There is not much in the way of pedestrian traffic through here, but those that I see are other compliant dog walkers and runners. I fail to see where this light use has prompted such significant issues that warrant discussion of change to such a recently adopted ordinance.

With nothing other than suspicion, if this is a veiled effort to address the Glenway Woods - technically part of the cemetery grounds as I understand it - then divide that area and address it independently. I am aware of the controversy of dog use of this section over the last three years, and that issue has never come before this commission even after the failed promises of improvements as part of the Glenway Golf Park renovation.

Madison is so lacking in public spaces for dogs and dog owners, compared to many comparably sized cities, that it still baffles and aggravates me seventeen years after moving here. Madison's policies are so extreme (compared to many cities that have found much more tolerant, equitable and effective approaches to dog spaces in an urban area), that dogs weren't even allowed in city parks at all until a few years ago, which was laughably regressive for the health and equal access of taxpayers with dogs. To revoke the use of the cemetery now would be equally shortsighted and inequitable.

A few people on the Regent Neighborhood listserve have complained about dogs disrespecting tombstones. To me this is a ludicrous argument. The maintenance crews use machines to mow and drive all around the tombstones, including right over the ground level ones. The rubber tire marks can be seen on the stones. Roundup being sprayed on stones is just as bad as the random dog urine droplets. My point is, the cemetery is a park. To keep the park in great shape requires some invasion of the "sacred" space. Is anyone up in arms about squirrels burying nuts and defecating around the graves? Birds pooping from trees. It's absurd.

Don't let a few scofflaws ruin the access to the cemetery for the vast majority who obey the leash laws. If you must, get the rangers out and enforce the leash laws just like you did in the adjacent Glenway Woods. During that blitzkrieg campaign of enforcement, those rangers were out there pouncing on dogwalkers and writing tickets at 7 am on Sunday mornings, and well after dark in the middle of winter (I am not exaggerating). Surely if they can manage that extreme level of enforcement, they can do it in the cemetery equally effectively. I live nearby and often walk in the cemetery to visit the graves of friends and relatives and I have purchased a burial plot there for myself. I truly value the beauty and peace of this special place in Madison. I also have a dog who occasionally walks with me on these visits, always on leash and always under control.

In the 40 years that I have lived in the area and visited Forest Hill I have never encountered an uncontrolled dog or seen any damage that could clearly be attributable to a family pet. Certainly there are many animals that live in Forest Hill and the woods nearby. I've seen foxes, raccoons, and the occasional coyote.

The neighborhoods that surround Forest Hill do not have a dog park or any legal unleashed area for dogs. There are many dog families in the neighborhood and virtually everyone is trying to keep their dogs safe, leashed and under control.
