I am writing to express JustDane's support for item 70 on your agenda this evening: ""Authorizing the allocation of up to \$1,750,000 to support community-based organizations (CBOs) in their work to deliver a continuum of services that respond to the post pandemic economy and meet the changing workforce needs of residents while focusing on youth, young adult, and adult employment services, as the result of a competitive RFP process conducted by the Community Development Division; and authorizing the Mayor and the City Clerk to enter into agreements with those agencies to implement the designated programs and services."

The funding recommendations have been moved forward by both the Community Services Committee and the Council Finance Committee without change. The recommended allocations recognize the need for funding in a variety of training and employment areas, as well as across age groups. All of us recognize that available funding is not sufficient to meet the needs that face our community. The funding recommendations before you this evening recognize that individuals enter training and the workforce with different skills, interests and needs and abilities. The recommendations take into consideration that some individuals need additional support to be successful in training and employment. That is certainly the case for many of the individuals who come through our Just Bakery program. Our community needs an array of services that will work with individuals who are unhoused, who may be experiencing substance use disorders and/or other mental health challenges, people who have experienced significant trauma, training that meets people where they are at. Finally, we appreciate that a significant amount of funding has been allocated for youth and young adult employment. Youth and young adult training programs serve as a protective factor for our children, offering them opportunities to learn skills, to gain a sense of self-efficacy, to become self-sufficient and to have a successful work experience as they prepare for adulthood. We appreciate the City's commitment to learning and to supporting an array of training initiatives and programs across the lifespan and urge you to vote yes on Item 70 this evening. Sincerely,

I was part of Maydm's internship program and given it and its ecosystem's profound impact on me, am writing to strongly recommend the City of Madison vote <u>in favor</u> of providing funding to Maydm for its internship program.

By teaching us life lessons and helping us build the necessary skills for the job market, Maydm paved a path for us to enter into internship opportunities in reputed companies. Maydm's weekly meetings included truly exceptional opportunities to connect with subject-matter experts and industry leaders. In addition, Maydm's support system included training for internship interviews and mentorship and helped land students traditionally marginalized in STEM in internships through the close-knit educational programs and mentors that prepared us with STEM skills, guidance, and confidence. I strongly believe Maydm is creating a difference for middle and high school students. Some of the specific highlights of the program are listed below:

- provided sessions that prepared us for internship interviews
- · gave us free access to a plethora of Coursera courses to empower us with knowledge and skills
