Feedback - Common Themes

- ▶ Focus on larger picture versus project details
- ▶ Maintain focus on equity, sustainability, and accessibility

UDC Purpose and Intent Statement

MGO 33.24, UDC Existing Purpose and Intent Statement:

- ▶ To assure the **highest quality of design for all public and private projects** in the City.
- ▶ To **protect and to improve the general appearance of all buildings, structures, landscaping and open areas in the City**; to encourage the protection of economic values and proper use of properties.

UDC Purpose and Intent Statement

MGO 33.24, UDC Existing Purpose and Intent Statement:

- ▶ To **encourage and promote a high quality in the design of new buildings, developments, remodeling and additions** so as to maintain and improve the established standards of property values within the City.
- ▶ To **foster civic pride in the beauty and nobler assets of the City**, and in all other ways possible assure a functionally efficient and visually attractive City in the future.

Why is the UDC review of projects important?
