- 1. Significance (and rate) of farmland loss in our community
- 2. Definition of Farmland Preservation for Task Force purposes

- 4. What metrics do we want to see in policy recommendations to measure progress
- 5. Can we quantify potential impacts of proposed policies?
- 6. How do we balance housing (or other developed uses) and food production?

## Land Access and Tenure (see Yang memo) (Volk, Voss, Yang)

- 1. Who needs farmland preservation in the city?

- 3. Explore revising Campus-Institutional zoning districts to allow urban ag
- 4. Location and review of city-owned parcels: currently leased for ag purposes, not being used for food production, available for temporary food production -- temporarily and/or long-term
- 5. Update community gardens map to specify which public agency controls city-owned land
- 6. Review of privately owned ag land within the City of Madison
