




2011 Sustainability Plan

Audience


- City of Madison staff are the primary audience.

Plan Overview

8 Elements – 24 goals, 73 actions

1. Quality Affordable Housing – 2 goals, 8 actions
2. Resilient City Design and Infrastructure – 4 goals, 13 actions
3. Renewable Energy and Decarbonization – 5 goals, 15 actions
4. Sustainable Transportation, 2 goals, 10 actions
5. Clean Abundant Water – 2 goals, 6 actions
6. Zero Waste – 1 goal, 2 actions
7. Healthy Ecosystems – 3 goals, 8 actions
8. Vibrant Green Economy – 5 goals, 11 actions



Resilient City Design & Infrastructure

Goal 4. Protect and increase the access to infill, neighborhood-scale sustainable farming and community gardening.

4.1. Develop and implement a mechanism for creating community gardens in partnership with community organizations following recommendations from the Madison Food Policy Council.

4.2. Create guidelines to inform both community and City decision-makers regarding planning and permitting for the remaining farmland in our community and ensure community members, especially renters, have access to garden space.
