



Feedback Themes

- Housing maintain housing affordability; displacement concerns; balance affordable & market rate units
- New development scale
- Redevelopment opportunities Bimbo, Car dealership, vacant homes, old bowling alley, etc.
- <u>Traffic and pedestrian conflicts</u> better crossings; more sidewalks; signals/rrfb; speed management







Feedback Themes

- No there there
 - Lack of neighborhood restaurants, cafes, or retail
 - Lack of community gathering places
 - Development encloses park spaces
 - No community events
- Barriers that separate residents
- Childcare, community services
- Employment access



Truax specific feedback

- Struggle accessing daily needs
 - Food, childcare, mental health support, senior services
- Youth concerns
 - Bring back basketball court (s), consider other rec facilities
 - Teens have trouble finding work accessible without a car
- Walking to school tunnel graffiti, loitering, garbage
- Water Quality PFAS
- More greenspace/better access






Public feedback → Shared Values and Intentions

- Welcome new development, respect sense of place (Recommendations 23, 41, 40)
- Reduce isolation by increasing connectivity (Recommendations 4,5,8)
- Better access to programming, activities, and employment (Recommendations 25, 46, 44)
- Improve aesthetics, wayfinding, and amenities along streets, bike paths, and in parks (Recommendations 31, 23, 26)
- Be a green and environmentally-friendly place (Recommendations 31, 34, 37)
- Build a sense of community be welcoming and celebrate uniqueness (Recommendations 23, 30, 55)

Draft recommendations

- Encourage new affordable housing

- Address flooding at Lexington/Hwy 51
- Partnerships to improve Starkweather
 Creek access and environmental quality



Near-Term Actions

- City led
 - E. Washington tunnel repaired pump to address flooding, cleaned garbage, graffiti, loitering up
 - Community murals, other public art
 - Technical assistance for neighborhood groups

Community - led

- Cleaned up graffiti on E. Washington tunnel mural
- Expand Hawthorne Community School and Walking School Bus
- Financial literacy workshops
- Neighborhood block parties, food cart nights, concert series and more
