The City of Madison has been working to address food waste and composting solutions for over 10 years. In 2021, the Madison Common Council passed a Resolution (RES-21-00618) setting a goal of food waste diversion from the landfill of 50% by 2030.

In 2021 there was a grant opportunity offered by the USDA through their Community Compost and Food Waste Reduction program. The City engaged with Sustain Dane, who successfully administered the City's inaugural Master Recycler program, to partner on the grant application. The City was successfully awarded the grant through the USDA and the Madison Common Council adopted Resolution RES-21-00714 to accept the grant award and amend the Sustainability Improvements Capital Budget with the \$90,000 in federal funding.

Sustain Dane has proven to be a reliable partner on administering the Naturally Occurring Affordable Housing project which consists of 3 grants totalling \$318,381. With their role in the award-winning Master Recycler program, we see the administration of the City of Madison's USDA funded Community Food Waste Reduction Initiative to be an extension of a this waste reduction and diversion partnership.

3/6/2023: ADDING ADDITIONAL FUNDS:

The City of Madison has been working to address food waste and composting solutions for over 10 years. In 2021, the Madison Common Council passed a Resolution (RES-21-00618) setting a goal of food waste diversion from the landfill of 50% by 2030.

In 2021, the City was awarded funding through the U.S. Department of Agriculture (USDA) Community Compost and Food Waste Reduction (CCFWR) grant program to support the City of Madison's Community Food Waste Reduction Initiative. The Madison Common Council adopted a resolution (RES-21-00714) to accept the grant award and a resolution (RES-22-00055) to contract with Sustain Dane to administer the Community Food Waste Reduction Initiative.

A key part of this initiative is collecting food scraps for recycling at farmers' markets during the 2022 and 2023 seasons. Sustain Dane has successfully administered this program and demonstrated incredible success during the 2022 season, collecting 10,765 pounds of food scraps for composting at the South Madison and Eastside farmers' markets.

For 2023, the USDA grant funding enables only 8 weeks of staffing at the two markets for 2023, and this additional funding will allow Sustain Dane to extend for the market drop-off for the complete seasons of the Eastside and South Madison farmers' markets, furthering the success of the program and keeping more food waste out of the landfill.

Sustain Dane is a proven partner in waste reduction efforts and a successful administrator of several City programs, including the Master Recycler Program and the NOAH Energy Efficiency work.

COMMENTS REGARDING PURCHASES OVER \$50,000

The City of Madison has paid Sustain Dane a total of \$684,088 since 2015. Of that, \$27,301 was made up of small purchases each under the threshold requiring competitive selection. The remaining amount of \$656,787 was all non-competitive.
