### Rules Governing BCC's

- MGO Chapter 33: Establishes and Regulates BCC's, including subcommittees
- Task Force on Government Structure (TFOGS)
  - Issued Final report in 2019
  - Recommendations for effective government and accountability include eliminating or combining BCCs that are redundant or have outlived their purpose.

Golf	Fees & policies specific to Golf
WPCRC Advisory	Fees & Policies specific to WPCRC
Facilities Programs & Fees	Permits, Fees & Policies related to use of space, programs and facilities for entire Parks system
Habitat Stewardship	Policies and Standards related to Land Management and Urban Forest through entire Parks system
Long-Range Planning	Policies and standards related to vision/mission and strategic planning efforts that shape the overall direction of the entire Parks System

# Options Presented to Board of Park Commissioners January 11, 2023

- Option 1: Maintain status quo with minor changes
  - Review number of members of each subcommittee
  - Set clear expectations on number of required meetings.
- Option 2: Consolidate Subcommittees
  - Assign duties of Golf and WPCRC Subcommittees to the Facilities, Programs, and Fees Subcommittee.
  - Addresses the redundancy in committee duties and TFOGS recommendations.
- BPC Unanimously voted to proceed with Option #2

## Updating BPC Rules of Procedure & Basic Policies

- Approving an Update to the Board of Park Commissioners Rules of Procedure and Basic Policies (Legislative File #76473)
  - Eliminates Golf Subcommittee & WPCRC Advisory Subcommittee
  - Consolidates duties of the subcommittees
  - Changes to Parks Contact info and meeting locations
  - Additional minor updates
  - Approved by Board of Park Commissioners March 8, 2023
  - Formally enacted following Council Approval of MGO Revision

## What does this mean for Golf Subcommittee?

- Following Council Enactment Golf and WPCRC Advisory Subcommittees will be eliminated
- Enactment Timeline: Likely late March
- Oversight of Golf Program:
  - Finance Committee & Common Council will continue to have Budgetary Authority over Operating & Capital Budgets
  - Board of Park Commissioners maintain authority over Golf Program
    - Staff will prepare regular Golf Program reports for BPC
  - Facilities Programs & Fees Subcommittee will advise regarding fees and programming, review public feedback
