Dear Council Members,

I am writing in support of Alder Barbara Vedder's resolution to engage the City of Madison to assist with the worsening personal care workforce crisis. As Executive Director of Access to Independence, as well as someone with experience providing personal cares for people with disabilities, I would like to share my thoughts on this issue, and ways the city could assist with solutions. While this issue is not going to be solved completely by the City of Madison, I believe there are ways for the city to help.

The long-term care workforce crisis has been worsening for several years, and is now at a point that threatens the systems that fund and provide these services, and the freedom and independence of those who rely on them. Even in Madison, often considered to be "resource rich", there are too many people with disabilities who cannot find workers for some or all of their shifts, providers who cannot find workers to fill shifts for their clients, and families who are providing care to a level that impacts their employment and wellbeing. The bulk of the solution rests with the state and federal government to address the rates paid for these services, as well as other barriers that are driving people away from the workforce. That said, something must be done while we wait on those solutions.

The impact of this crisis is real, and here is a graphic to demonstrate that impact on the lives of people with disabilities across the state of Wisconsin. The graphic is courtesy of the Survival Coalition of Wisconsin Disability Organizations.



None of us should be content knowing so many of our family, friends, and neighbors are not entitled to the same basic rights and opportunities as the rest of us.

I believe there are creative ways the City of Madison can support the workforce, and residents who rely on these services. Some ideas might include:

- Development of a local care cooperative to support residents with recruitment, hiring, and orientation of workers; create a pool of backup workers; and develop an information-sharing network. The cooperative could also be explored for providing workers access to benefits offered city employees.
- Local tax incentives for workers, or a sales tax holiday for workers.
- Provide workers access to free transit services, or vouchers for cab rides.

I appreciate Alder Vedder's efforts to involve the city in solutions to this crisis, and believe the support of the Common Council, and leadership of the Disability Rights Commission is important to that effort.

In my current work as an Independent Living Specialist, I hear every day about the challenges that people with disabilities face in finding reliable and trustworthy workers to meet their personal care needs. I also hear from family caregivers who have no dependable respite for the care they provide to their loved ones - often 24 hours a day 7 days a week. Over the years, many of these people have become my friends. I could share any number of horror stories about vulnerable people who have been taken advantage of and even abused by personal care workers. For every one of these stories, I could share another about the unique bond that sometimes forms between people with disabilities and workers who value the work experience and dedicate themselves to supporting people to live their best lives. This work is hard, and it deserves better compensation and benefits to attract people who value the lives that are, quite literally, in their hands. I applaud any effort to try and find creative ways to address this crisis for Madisonians with disabilities and their families. But this is not an issue that is unique to Madison.
