



2023 Traffic Enforcement Goals

- 5. Respond to Community Member Complaints




Traffic Grant Corridors / High Injury Network



Traffic Grants

- The Madison Police Department, in partnership with the Dane County Sheriff's Office, conduct extra patrols that, depending on the time of year, focus on enforcing Wisconsin's alcohol, seatbelt, and speed laws.
- These additional enforcement efforts are made possible through traffic overtime grants provided by the Wisconsin Department of Transportation.
- The goal of these extra patrols is not only to enhance public safety, but to prevent needless tragedies.
- Traffic grant activity is not confined to just the High Injury Network. Because MPD collaborates with the DCSO on alcohol, seatbelt and speed grants, grant activity must be held on city streets that are also county highways.



Traffic Grants

- All alcohol grant activity must take place after 6:00 p.m. on Friday and Saturday
- 50% of seatbelt grant activity must take place after 6:00 p.m.
- In addition to the grants, the Madison Police Department participates in the Wisconsin Department of Transportation's "Drive Sober or Get Pulled Over" and "Click It or Ticket" (5/22/23 – 6/4/23) campaigns.
- The City of Madison also manages our own Pedestrian/Bike grants that are funded by the State of Wisconsin DOT. We just received this funding and will begin grant activity in June.

Fatality Crashes


- The City of Madison had a total of 3 fatality crashes in the first quarter of 2023.
- The following three slides summarize each of those three crashes.



Fatal Crash Summary

- Date: 02/05/2023
- Time: 6:20 p.m.
- Location: Packers Ave./Anhalt Dr.
- Type: MV vs. MV
- Synopsis Involved vehicle #1 was stopped in traffic on Packers Avenue waiting to make a left turn onto Anhalt Drive when it was struck from behind by involved vehicle #2. The driver of involved vehicle #2 was traveling approximately 35mph, made no attempt to stop and made no lane maneuver prior to colliding with involved vehicle #1. Drive of involved vehicle #2 was pronounced deceased at the hospital. There was no evidence located on scene/in the vehicle/on the driver to indicate the driver was impaired.






Fatal Crash Summary

- Date: 02/15/2023
- Time: 9:30 p.m.
- Location: Schroeder Rd./Struck St.
- Type: MV vs Pedestrian & Dog
- Summary: A witness, who was traveling westbound on Schroeder road behind two vehicles, reported that she observed one of the vehicles swerve and pull over to the side of the road with the vehicle's hazard lights on. As the witness drove past that vehicle, she noted that the vehicle was blue in color. She also noted seeing the deceased and his dog lying in the road, though she did not know at the time that what she was seeing was a human and a dog.
- Causative Factors: Impaired Driving, Speed (suspected)






Fatal Crash Summary


- Date: 03/02/2023
- Time: 12:15 p.m.
- Location: S. Gammon Rd./Schroeder Rd.
- Type: MV vs. Tree
- Summary: According to witnesses, a vehicle traveling southbound on Gammon Road left the roadway, driving on the sidewalk, at approximately 45mph. It appeared, according to witnesses, that the driver of the vehicle tried to correct and drive back towards the road prior to striking a tree. Three occupants in the vehicle; driver deceased on scene. Both passengers had very significant injuries, but survived the crash.
- Causative Factors: Unknown




Serious Injury and Fatal Crashes





Serious Injury and Fatal Crashes






School Zone Safety

- The City of Madison Police Department's Traffic Enforcement and Safety Team (TEST) will continue to make school safety a priority in 2023.
- Every Tuesday, Wednesday, and Thursday, TEST officers begin their day at specific schools listed on the school rotation calendar.
- On Mondays and Fridays TEST officers focus on issues in their respective districts. However, TEST officers also respond to schools and school zone complaints in their respective districts as a part of their morning routine.
- In addition to providing a high-visibility presence to deter unsafe driving and enforcing school zone violations they observe, TEST officers work with the schools, bus drivers, and crossing guards to address specific, chronic issues.
- TEST members work closely with Traffic Engineering if and when signage is needed to improve school zone safety.
