Hello, I sent the message below to the Parks Long Range Planning Committee, but I never received a response and see that it has not been included in the public comments compiled for the June 14 full board meeting. I am extremely concerned that the plan to re-evaluate the current dog-free park system minimizes participation from those vulnerable groups most likely to be impacted by allowing dogs in all parks- mainly seniors and people like myself with disabilities. There are no signs posted in the parks notifying the people who rely on dog-free parks about the change, all outreach about this occurs online, and there are no plans to reach out specifically to the vulnerable groups who need access to dog-free parks: disabled, elderly, very young, neurodivergent, and those suffering panic and anxiety disorders after dog-related trauma.

It's disappointing to see no effort being put forth to treat this accessibility issue with equitability and justice in mind. I will certainly submit a comment detailing my own terrifying experiences with dogs in parks and why I cannot recreate safely in the presence of dogs, but that doesn't get at the bigger issue, which is the fundamental inequity in making accessibility decisions without reaching out to the people who will most be impacted by the loss of dog-free parks.

Hello,

I was alarmed to see in the minutes from the recent Parks Long Range Planning Subcommittee that a recommendation is being made to remove dog free status from Madison Parks. As a

disabled person, this is a pure issue of accessibility and equity for me. I cannot safely recreate around dogs, and neither can many of our most vulnerable community members, including the disabled, elderly, very young, neurodivergent, and those suffering panic and anxiety disorders after dog-related trauma.

I'm extremely concerned that nowhere in the committee's recommendation memo is there any mention of accessibility needs or how this issue will be viewed as an equity and inclusion item. The plans for public comment and participation in the topic seem to be exclusively electronic, meaning that these same groups who will be denied a safe place to recreate if dog free park status is eliminated will also be at a disadvantage when it comes to voicing their opinions. The disabled and elderly especially are less likely to have a voice in the process.

Did the committee discuss the equity and accessibility components of the recommendation or consider how to address these issues at all in the public participation process? I think denying multiple groups of vulnerable community members access to safe places to recreate and enjoy nature should be considered with extreme caution and handled in a way that carefully considers the equity and inclusion impacts. So far I am not seeing anything to that effect.

Can you please take a step back and think about this issue with equity and inclusion in mind? Thank you,
