



Q4 Does your building have access other than State Street that could accommodate deliveries, loading and/or residential move in/out?




Q6 How many employees (FTEs) do you have on site?







Q7 Does your building have residences on the second floor or above?









Q10 Do you support closing the street only when the space can be activated with programing or events? (Night Market, Cars on State, Maxwell Street Days, etc.)











Q17 Do you receive any weekend freight, parcel or food deliveries?





Q18 For residential move-ins/outs where access is required from State Street, what times are you most likely to use? (check all that apply)






