Dear Aldermen and Alderwomen,

First, thank you for your service to your community. Trusted stewards like you are what's made the City of Madison a nice place to be as a graduate student.

My name is Jacquelyn Adamicki, and I am a 27-year old 3rd year law student at the University of Wisconsin. I have lived in the City of Madison for the last 6 years as I worked at the State Capitol in the Wisconsin State Legislature prior to starting law school 2 years ago.

I write to you today asking you to vote NO on unaffordable student housing, particularly large-scale, purportedly "luxury" apartment complexes with unnecessary amenities and painstakingly unaffordable rental prices.

Affordable Housing is already so difficult to find in Madison, particularly for graduate level students who do not wish to live amongst those under 21 but cannot afford luxury apartments as we are in school. Tuition and the cost of living is skyrocketing which only adds to the burden of finding affordable housing for several years. Graduate students in particular need affordable housing options near campus especially because our student loan interest does not defer like it does for undergraduate students and we are expected to make payments while full time in school. Affordable housing is a key, if not one of the most important, factors a graduate student considers when making their decision on where to pursue their advanced degree. Aside from tuition price/scholarships alone, cost of living was the number one most important factor in my decision to attend the University of Wisconsin for my law degree, versus all the other law schools I was admitted to and received scholarship offers for. It would be a shame for Madison's future intellectual and professional talent to be priced out and discouraged from attending the university due to affordable housing shortages.

When I needed to move closer to campus, the lack of safe, affordable, respectable options was especially frustrating. As a 27-year old law student, I was not interested in living in a boisterous apartment complex with undergraduate students and superfluous amenities like pools that can only be used for maybe 3 months of the year. I wanted something quiet, affordable and just well kept so I can focus on my studies. But after searching to no avail, I

had to go 15 minutes away from campus over my Hilldale Mall to find what I was looking for. I love my apartment but it's become unaffordable as my base rent has increased over 400 since I signed 2 years ago. In fact, the unaffordable housing market in general is what ultimately led me to my decision to change course, and leave Madison after graduation. The housing market is just not appealing, let alone feasible, for recent graduates and young professionals.

Affordable housing for graduate students is imperative for the city of Madison. Otherwise prospective students will start going to higher ranked universities if the cost of living in Madison is on par with Chicago or New York City.

Madison is not Chicago or Manhattan. Neither the city nor the state of Wisconsin has the ability to pride itself as such without sacrificing valuable talent for more reasonably affordable Midwest cities.

In sum affordability is the biggest consideration for graduate students like myself. Please vote no on unfortunate proposals for even more luxury apartments with unreasonable rent prices. All it's doing is making going to school in the City of Madison an unaffordable option for current students, and further discouraging prospective students from choosing the University of Wisconsin.

Please see below for Madison is for People's statement on the rejection of Core Space's downtown rezoning proposal:

"The Council's vote last week was a missed opportunity to add 157 much-needed homes to Madison. Core Spaces' decision to not include affordable units under the city's <u>Development Bonus program</u> was likewise a missed opportunity to further increase supply while providing housing at a variety of price points.

To bring down housing costs, we must increase the supply of housing at all price levels so that there is enough to go around. The Council's focus on housing affordability is commendable, but rejecting the project ultimately leaves us with neither additional housing nor affordable housing.

We encourage the Council, the University, and developers to help increase affordability by:

Adding more housing options for everyone – including students

- Since 2018, UW-Madison has <u>added over 5,000 undergraduate students</u>. In the same period the University has only <u>added</u> about <u>600 spots in undergraduate dorms</u>. Recent capital spending on student housing has focused on improving amenities rather than increasing capacity. That's not sustainable.
- UW should use every available tool to expand its housing offerings for the additional students it accepts. Prioritizing undergraduate housing over parking lots in the upcoming <u>West Campus District plan</u> would be a strong start.
- Where the University can't or won't step in, the city should pick up the slack. This should include seeking higher density in near-campus areas, including South Park St., Regent St., and University Ave as well as removing height restrictions for new developments where possible.

Strengthening and expanding the Development Bonus program

- More housing choices make housing more affordable. The Development Bonus program attacks Madison's housing crisis from both sides by encouraging more units and ensuring that many of those units are affordable.
- Madison should expand this idea across the city and encourage developers to take advantage of the program, allowing us to welcome more neighbors to our neighborhoods.
- Because students do not qualify for affordable housing that is based on AMI, the Council should alter the Downtown Height Bonus to allow for additional floors if affordable student housing is included in a project.
