I'm eager to see this big part of my neighborhood be used effectively. I hope it not only provides a lot of much-needed housing, but also the Milwaukee Street corridor could really use more activated frontage, to provide destinations for new and old neighbors alike. That was one of the big disappointments when we couldn't rezone the Amazon property just east of the farm.

If there's to be a connection to Chicago Ave, let's not make it a vehicular cut-through. That won't be good for anybody. A pedestrian bridge would be great, especially if a narrower right of way means Jeanie Kramer doesn't have to lose her house on Fair Oaks.

Regarding the connections to Milwaukee Street, I don't see a problem with disrupting Milwaukee Street traffic. If anything, it could use more natural traffic calming! However, if it's a choice between one street that meets signal warrants vs. three that do not, a signalized intersection would be a lot safer for pedestrians and cyclists.
