Audience: Policy makers, general public and Parks staff

Why Issue Papers: Parks has a few overarching challenges we face in the coming years and these will provide us with a chance to document where we are and where we plan to be 5 or 10 years from now. They will be a written resource that we can use to share with new staff, new policy makers, and partners to provide background information and justification for our recommendations.

Themes that will emerge in each: Equity, Fiscal Stewardship, Environmental Responsibility, please attempt to include mentions of these themes and how your issue relates.

Land Management and Stewardship

Process for developing the issue papers

- Ann, CJ and Kate will lead effort. (Providing guidance, schedule management and QA/QC.)
- The intern, a different Ann, will conduct interviews with staff and draft outline for each paper. Draft outlines will be reviewed by SME and Lead Staff. (January)
- After review by Ann, CJ or Kate, the intern will review the outline with the LRP rep assigned to that paper. (February)
- After outlines are OKed, the intern will write a draft of each issue paper (1 to 3 pages max length). (Feb/March)
- Ann and Kate will bring the draft issue papers to the Management Team for review and comments. (Late March, early April)

- General outline
 - O Why is this important?
 - O Where are we right now with this issue?
 - O Where do we want to be in 5 to 10 years?
 - O What are some ways to know if we are being successful?
