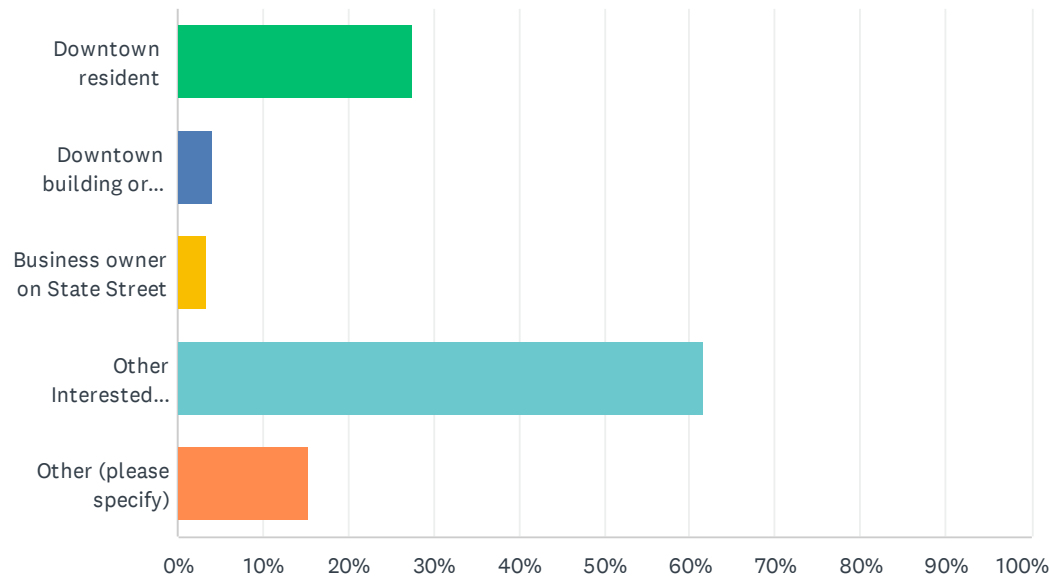


Q1 What is your relationship to the street (check all that apply)

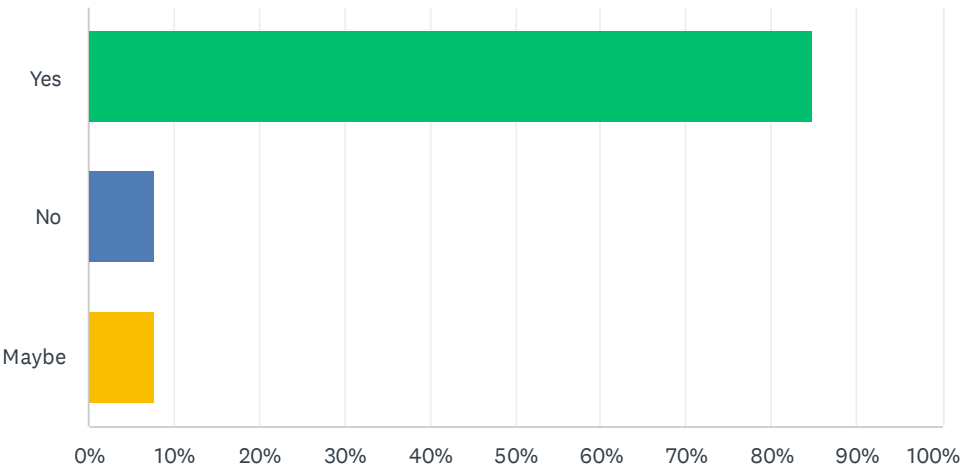

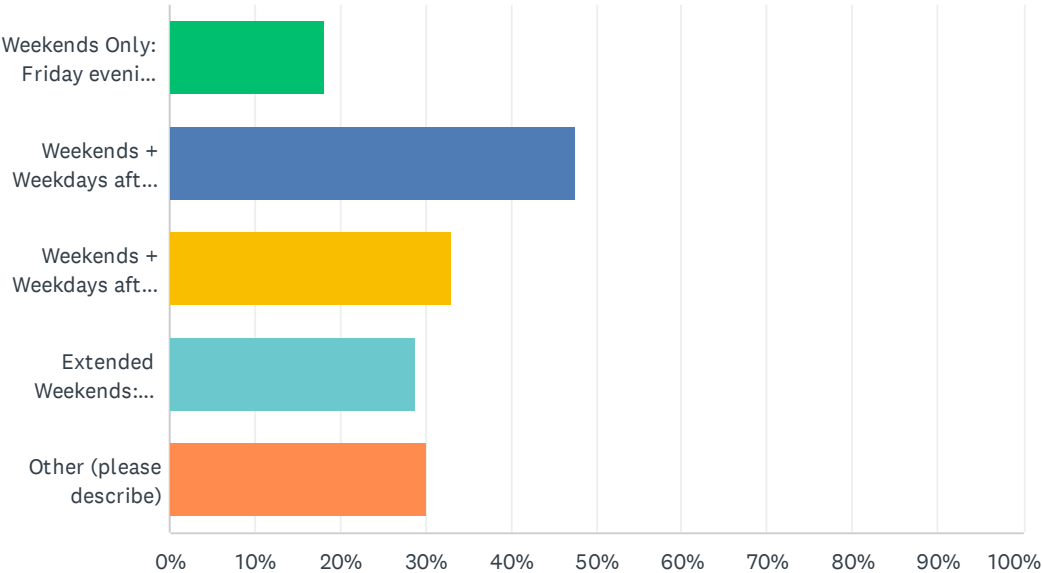

Q8 What times, if any, would you support closing the 400-600 blocks of State Street to all vehicular traffic?

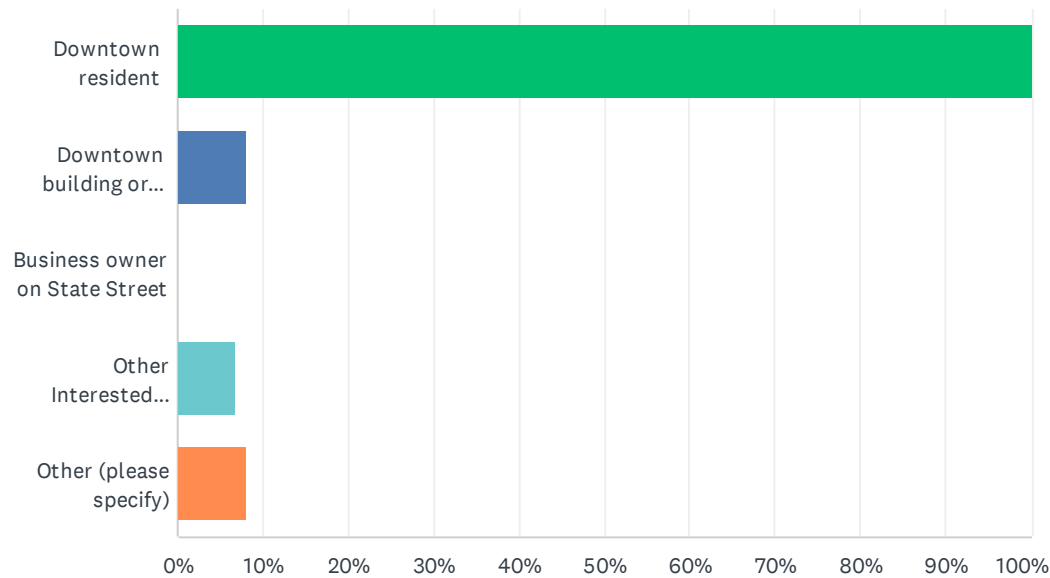

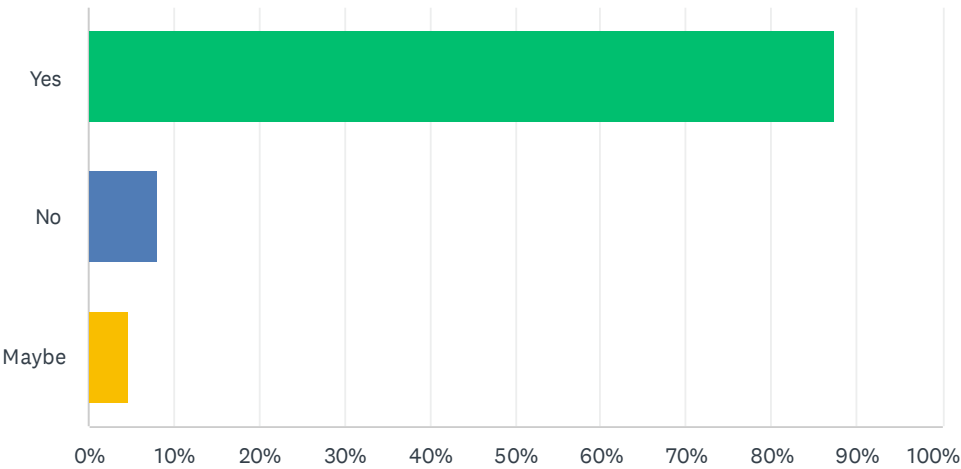
