Street Lighting Installation Assessment: The rate for street lighting is calculated based on the total construction costs divided by the net linear frontage for parcels that have access to Ohmeda Drive.

Sanitary Sewer Installation Assessment: The rate for sanitary sewer installation is calculated based on the total construction costs (minus lateral costs) divided by the total net square footage receiving service (Total cost is divided by receiving lot area (gross area) and cost divided by area of first 200' from ROW (proximity).

Water Main Installation Assessment: The rate for water main installation is calculated based on the total construction costs (minus service costs) divided by the total net square footage that will receive service from this main.

Storm Sewer Installation Assessment: The rate for sort one service installation on Ohmeda Dr. (3204 Ohmeda Dr. (3204 Ohmeda Dr.)

In accordance with Madison General Ordinance 4.081, the assessments for parcels toned or used for agriculture and in the City of Madison shall be deferred for 10 years with interest. Upon completion of the deferral period, payment shall be made with interest in 8 equal yearly installments.
