### **Public Art Updates**

#### **Atwood Avenue Percent for Art Plan**

Multiple locations on Atwood Ave, District 15



- Poetry in Sidewalks by 2022 Youth Poet Laureate Madeleine Bohn and Poet Laureate Angie Trudell Vasquez are installed on Atwood Avenue.
- Utility box wraps by Rachel Durfee, Chris Murphy, Eloisa Calendar will be installed this summer.
- Path medallions designed by Daniella Echeverria (above) are expected to be installed in 2024.

# **Bartillon Shelter Percent for Art Plan -** Legistar File 78514 1904 Bartillon Dr, District 12



- Madison Arts and Engineering staff consulted with artist Lillian Sizemore on a potential design for a mosaic on the front façade.
- The proposed mosaic locations were included in the Bartillon Shelter proposal that was approved by Urban Design Commission on Wednesday, February 14, 2024.
- Staff will develop an RFQ for a mosaic artist to design and develop mosaics to fit the proposed locations. Applications will be reviewed by MAC.
- We anticipate we will also run a call for existing artwork to license or purchase for interior sites.

Starkweather Creek Bike Path at E Washington Avenue, District 12



- The artist identified a site in the along E Washington and the Bike Path.
- Staff received updated designs from the artist and incorporated them into the community survey.
- The survey will be distributed to neighborhood residents & stakeholders this spring.
- Anticipated production and installation will be Summer/Fall 2024.

#### **Imagination Center at Reindahl Park Percent for Art Plan**

1818 Portage Road, District 12





- Staff from The Bubbler and Madison Arts are partnering on the public art plan.
- In consultation with Parks, Engineering, and Library staff have identified a site for a sculpture.
- In Spring, 2024 we anticipate launching an RFQ.
- We transferred Percent for Art funds from the Metro Transit Hansen Road Facility to bolster the budget of this project.

- Staff will draft educational information to be reviewed by the Artist and other stakeholders.

#### **Utility Boxes – Sister City Collaboration**





- This year we are prioritizing the boxes on University Avenue & Atwood Avenue, and cleaning some boxes that have been tagged.
- Funding permitting, we may partner with Sister Cities to wrap 10 boxes.

#### West Area and North-East Area Plans

- Madison Arts staff worked with colleagues in the Planning Division to host arts workshops in conjunction with both the West Area and North-East Area Plans.
- The workshops identified opportunities and challenges that staff incorporated into the plan as recommendations.
- The West Area Plan draft is currently available to the public for comments. You can provide feedback in many ways, <u>including via person meetings and online</u>. North-East Area plan will be available for review in the coming months.

#### **Sid Boyum Sculpture**

S Livingston Street at Capital City Trail, District 6





- A Sid Boyum sculpture located along the Capital City Trail is in need of conservation work to repair the "tail" of the sculpture.
- Staff will research potential concrete conservators.

#### Timekeeper

Law Park, 410 S Blair St, District 4



- Metal and granite surfaces of the sculpture were restored and polished in 2023.
- New granite will be laid in the coming months, pending artist and Parks approval of stone.
