To: Property Owners along Stevens Street
Re: Proposed Street Resurfacing Project & Public Hearing

The City of Madison is planning a 2024 project on Stevens Street (from N Franklin Avenue to Grand Avenue). Construction in Stevens Street will start in summer of 2024 and is expected to end in fall of 2024. Enclosed with this letter is a fact sheet with some details on the proposed project. Also enclosed is a notification for the Public Hearing before the Board of Public Works. The date, time and location of the public hearing is on the notification.



This project will involve special assessments to the owners of property adjacent to the project. The property owners will be assessed for various items included with this proposed project, and the costs of some of those items are assessed entirely to the owner. Tables detailing the City’s standard assessment policy for the items of work is included on the fact sheet.

Below is a preliminary Schedule of Assessments, which shows the estimated costs for your property adjacent to the project. The Schedule of Assessments for all properties adjacent to the project is available on the project webpage at: <https://www.cityofmadison.com/engineering/projects/north-franklin-avenue-and-stevens-street-resurfacing>; a hard copy can be mailed to you upon request. The frontages and lot areas of each property to be assessed are listed on the full schedule. After work is complete, a final assessment cost will be calculated based on bid prices and work actually performed. The final assessment cost, which will be billed after the completion of the project, is payable in one lump sum or over a period of 8 years, with 5% interest charged on the unpaid balance.

Fact and Details Sheet: **PROPOSED STEVENS STREET RESURFACING WITH UTILITIES**

Project Details – Proposed Work

Sanitary Sewer: The City will remove and replace the existing 6" clay pipe sewer main in Stevens St with new 8" PVC pipes and replace laterals from the new main to the property line within the project limits (N Franklin Ave to Grand Ave). In limited cases where the existing lateral is cast iron, appears to be in good condition upon inspection, and runs under a tree, the lateral will only be replaced to the back of curb. In those cases, the owner will not be assessed for the additional footage of replacement that is not completed. If you would like a full lateral replacement to the property line in cases such as this, please contact the Project Manager (*laterals assessable*).

Water Main: The City will not replace the water main along the street.

Storm Sewer: The City will replace inlets that are found in poor condition.

Street: The City will replace all of the existing base course and pavement on Stevens St and the curb on Stevens St from N Franklin Ave to Farley Ave. New sidewalk is proposed along the north side of Stevens St to connect the park to the existing sidewalk on N Franklin Ave. Stevens St. from N Franklin Ave. to Farley Ave., is proposed to have a 22 ft wide section nearest Franklin (from face of curb to face of curb, reduced from 30 ft) with no on street parking for that segment. The narrowing of Stevens St from 30 ft to 22ft is due to the addition of sidewalk, while avoiding conflict with the existing trees. With the proposed design, the street will transition to 26 ft wide (from face of curb to face of curb, reduced from 30 ft) with 5 ft sidewalk to remain on both sides of the street and 8.5 ft terraces on the south side and terraces varying from 3 ft to 12 ft on the north part of the street. In this section, on street parking will be maintained on the south side of the street. Stevens St, from Farley Ave to Grand Ave is proposed to maintain its current dimensions (26 ft wide from face of curb to face of curb), 5 ft sidewalk on both sides, and 10.5 ft terraces. Curb and gutter, sidewalk and driveway aprons will be spot replaced.



During construction, the medians in the Stevens St and Farley Ave intersection may be removed and replaced due to replacement of utilities. City Engineering would like to invite neighborhood volunteers to plant and maintain these medians with the Adopt a Median program (<https://www.cityofmadison.com/engineering/stormwater/programs-initiatives/adopt-a-median>). Median volunteers are asked to fill out the program application and waiver by September 2024 (date 1 month into construction). In the absence of volunteers, the traffic medians will be constructed with colored stamped concrete instead of a planting area. Driveway Aprons: Driveway aprons will be spot replaced with concrete as needed, if they're in poor condition or if impacted by other street or utility work. Driveway aprons will be replaced per the City of Madison standard detail. (*Driveway aprons assessable*)

Bus pads: Bus pads will not be installed along Stevens St.

Street Lights: There are no proposed changes to street lighting along Stevens St.

Trees: There are no planned tree removals within the project limits. If, during construction, it is determined that any additional trees must be removed, adjacent property owners will be notified, prior to removal of the tree. The trees within the project limits that remain may have the roots trimmed during construction.

Terrace tree pruning in advance of the project is required to reduce the risk of damage to the trees during construction from equipment. The City of Madison Forestry Section will perform the necessary work. For certain species, especially oak and elm trees,

the pruning must be completed by June 1st to reduce the chance of disease. If additional trees need to be removed, City Engineering will notify the adjacent property owner prior to removal.

Street trees provide many benefits to our city and are considered an important part of the City’s infrastructure. Initial coordination with Forestry has been completed for potential new planting locations and will continue during design and after project completion. There is no additional cost to the adjacent property owner for a tree planting. Street trees are typically planted in the spring of the year following the completion of the construction project. Per Madison General Ordinance 10.10, City Forestry determines tree species and planting locations. Residents cannot choose or plant their own tree in the terrace.

For any questions regarding street tree maintenance or planting, please contact the general forestry line at 266-4816.

Assessments: The project will have special assessments for the street construction. The assessments are a special charge for work being done that has a direct benefit to the property. The preliminary assessments are mailed during the design phase and will give the property owner an estimated cost due, after construction is complete. The final assessment bill will be mailed in 2025 to adjacent property owners. The bill is calculated based on measured quantities for driveway aprons removed and replaced during construction. The unit prices for driveway aprons and pavement are based on 2024 street improvement rates and will carry over from the preliminary assessment to the final assessments. The sanitary sewer laterals and private storm sewer connections will be billed based on bid prices and measured quantities during construction. The property payment options include payment by lump sum or over eight years with 5 percent interest.

Construction Schedule & Impacts

Tentative Schedule: This project is scheduled to be bid in Spring of 2024. Construction work along Stevens St is expected to begin in summer 2024 and be completed by fall 2024.

Traffic Impacts: Stevens St will be closed to through traffic within the project limits until the project is complete. Local access will be provided, but driveways may not be accessible at times when work is being performed in front of the driveway and while new curb and gutter, sidewalk, or driveway aprons are constructed. Driveway closures may last up to a cumulative total of 20 days during the project, primarily when driveway aprons, curb & gutter, and sidewalks are being installed. No parking is allowed within the construction zone during working hours (7AM to 7PM), so when your driveway is not accessible, you will need to park on the adjacent streets outside the project limits; N Franklin Ave, Farley Ave, and Grand Ave. The contractor will notify impacted residents prior to the driveway access being closed for an extended period, but there likely be several short-duration closures during utility work and asphalt paving that may not have much advance notice. During these shorter disruptions, the Contractor will work with residents to provide access as quickly as possible. Contact the project manager if you have accessibility concerns and need to request special accommodations.

Water Shut-offs: There are no planned water shut-offs. While unlikely, emergency shut offs are possible if the existing main is damaged during construction. Affected properties are notified as soon as possible.

Refuse Collection: It will be the contractor’s responsibility to allow for refuse collection to continue during construction. Please mark your address on your cart to make sure it is returned if moved. We ask that you place your carts at the street the evening prior to or at the very latest 6:00 a.m. the morning of your scheduled refuse/recycling day.

Landscaping: Existing landscaping plantings within the terrace (between curb & sidewalk) may be impacted. If you wish to save any landscaping, it should be removed prior to the start of Stevens St work in 2024. Stone or brick pavers within the terrace you wish to save should be removed prior to construction and you may reinstall those items after construction is complete.
